A BILL

To require the Secretary of Defense to provide to Congress copies and descriptions of contracts and task orders in excess of \$1,000,000 for work to be performed in Iraq and Afghanistan.

1	SECTION 1. REQUIREMENT TO PROVIDE TO CONGRESS
2	COPIES AND DESCRIPTIONS OF CONTRACTS
3	AND TASK ORDERS IN EXCESS OF \$1,000,000
4	FOR WORK TO BE PERFORMED IN IRAQ AND
5	AFGHANISTAN.
6	(a) Monthly Requirement as to New Con-
7	TRACTS AND TASK ORDERS.—Each month, the Secretary
8	of Defense shall provide to the chairman and to the rank-
9	ing minority member of each of the committees of Con-
10	gress specified in subsection (c) a copy of, and a descrip-
11	tion of the work to be performed under, each new contract,
12	and each new task order issued under an existing contract,
13	in an amount greater than \$1,000,000 entered into by the
14	Department of Defense during the preceding month for
15	work to be performed in Iraq and Afghanistan.
16	(b) REQUIREMENT AS TO CONTRACTS AND TASK OR-
17	DERS BEFORE ENACTMENT.—Not later than 180 days
18	after the date of the enactment of this Act, the Secretary
19	of Defense shall provide to the chairman and to the rank-
20	ing minority member of each of the committees of Con-
21	gress specified in subsection (c) a copy of, and a descrip-
22	tion of the work performed or to be performed under, each
23	contract, and each task order issued under an existing
24	contract, in an amount greater than \$1,000,000 entered
25	into by the Department of Defense during the period be-
26	ginning October 1, 2001, and ending on the last day of
