A BILL

To amend the Internal Revenue Code of 1986 to provide to employers a tax credit for compensation paid during the period employees are performing service as members of the Ready Reserve or the National Guard.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. READY RESERVE-NATIONAL GUARD EMPLOYEE
- 4 CREDIT ADDED TO GENERAL BUSINESS
- 5 CREDIT.
- 6 (a) Ready Reserve-National Guard Credit.—
- 7 Subpart D of part IV of subchapter A of chapter 1 of
- 8 the Internal Revenue Code of 1986 (relating to business-

- 1 related credits) is amended by adding at the end the fol-
- 2 lowing new section:
- 3 "SEC. 45G. READY RESERVE-NATIONAL GUARD EMPLOYEE
- 4 CREDIT.
- 5 "(a) General Rule.—For purposes of section 38,
- 6 the Ready Reserve-National Guard employee credit deter-
- 7 mined under this section for the taxable year is an amount
- 8 equal to 50 percent of the actual compensation amount
- 9 for the taxable year.
- 10 "(b) Definition of Actual Compensation
- 11 Amount.—For purposes of this section, the term 'actual
- 12 compensation amount' means the amount of compensation
- 13 paid or incurred by an employer with respect to a Ready
- 14 Reserve-National Guard employee on any day during a
- 15 taxable year when the employee was absent from employ-
- 16 ment for the purpose of performing qualified active duty.
- 17 "(c) Limitation.—No credit shall be allowed under
- 18 subsection (a) with respect to a Ready Reserve-National
- 19 Guard employee who performs qualified active duty on any
- 20 day on which the employee was not scheduled to work (for
- 21 a reason other than to participate in qualified active duty)
- 22 and ordinarily would not have worked.
- 23 "(d) Definitions.—For purposes of this section—
- 24 "(1) QUALIFIED ACTIVE DUTY.—The term
- 25 'qualified active duty' means—

- "(A) active duty, other than the training 1 2 duty specified in section 10147 of title 10, United States Code (relating to training re-3 4 quirements for the Ready Reserve), or section 5 502(a) of title 32, United States Code (relating 6 to required drills and field exercises for the Na-7 tional Guard), in connection with which an em-8 ployee is entitled to reemployment rights and 9 other benefits or to a leave of absence from em-10 ployment under chapter 43 of title 38, United 11 States Code, and
 - "(B) hospitalization incident to such duty.
 - "(2) COMPENSATION.—The term 'compensation' means any remuneration for employment, whether in cash or in kind, which is paid or incurred by a taxpayer and which is deductible from the taxpayer's gross income under section 162(a)(1).
 - "(3) Ready Reserve-National Guard EM-PLOYEE.—The term 'Ready Reserve-National Guard employee' means an employee who is a member of the Ready Reserve or of the National Guard.
 - "(4) NATIONAL GUARD.—The term 'National Guard' has the meaning given such term by section 101(c)(1) of title 10, United States Code.

- The table of sections for subpart D of part IV of sub-
- 14 chapter A of chapter 1 of the Internal Revenue Code of
- 15 1986 is amended by inserting after the item relating to
- 16 section 45F the following new item:

"Sec. 45G. Ready Reserve-National Guard employee credit.".

17 SEC. 3. EFFECTIVE DATE.

- 18 The amendments made by this Act shall apply to tax-
- 19 able years beginning after December 31, 2002.
