A BILL

To further the purposes of the Sand Creek Massacre National Historic Site Establishment Act of 2000.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Sand Creek Massacre
- 5 National Historic Site Trust Act of 2004".
- 6 SEC. 2. DECLARATION OF POLICY.
- 7 To further the purposes of the Sand Creek Massacre
- 8 National Historic Site Establishment Act of 2000 (16
- 9 U.S.C. 461 note; Public Law 106-465), this Act author-
- 10 izes the United States to take certain land in Kiowa Coun-

2	of Oklahoma, into trust.
3	SEC. 3. DEFINITIONS.
4	In this Act:
5	(1) Secretary.—The term "Secretary" means
6	the Secretary of the Interior.
7	(2) Tribe.—The term "Tribe" means the
8	Cheyenne and Arapaho Tribes of Oklahoma, a feder-
9	ally recognized Indian tribe.

- half of the NW quarter, the SW quarter of the NE

- 17 SEC. 5. SURVEY OF BOUNDARY LINE; PUBLICATION OF DE-
- 18 SCRIPTION.
- 19 (a) Survey of Boundary Line.—To accurately es-
- 20 tablish the boundary of the trust property, the Secretary
- 21 shall, not later than 180 days after the date of enactment
- 22 of this Act, cause a survey to be conducted by the Office
- 23 of Cadastral Survey of the Bureau of Land Management
- 24 of the boundary lines described in section 4(b).
- 25 (b) Publication of Land Description.—

- 1 (1) IN GENERAL.—On completion of the survey
 2 under subsection (a), and acceptance of the survey
 3 by the representatives of the Tribe, the Secretary
 4 shall cause the full metes and bounds description of
 5 the lines, with a full and accurate description of the
 6 trust property, to be published in the Federal Reg7 ister.
- 8 (2) Effect.—The descriptions shall, on publi-9 cation, constitute the official descriptions of the 10 trust property.

11 SEC. 6. ADMINISTRATION OF TRUST PROPERTY.

- 12 (a) In General.—The trust property is declared to 13 be part of the Indian reservation of the Tribe.
- 14 (b) Administration.—The trust property shall be
- 15 administered in perpetuity by the Secretary in accordance
- 16 with the law generally applicable to property held in trust
- 17 by the United States for the benefit of Indian tribes and
- 18 in accordance with the Sand Creek Massacre National
- 19 Historic Site Establishment Act of 2000 (16 U.S.C. 461
- 20 note; Public Law 106–465).

21 SEC. 7. RELIGIOUS AND CULTURAL USES.

- 22 (a) In General.—The trust property shall be used
- 23 only for historic, religious, or cultural uses that are com-
- 24 patible with the use of the land as a national historic site.

- 1 (b) Duty of the Secretary.—The Secretary shall
- 2 take such action as is necessary to ensure that the trust

3 property is used only in accordance with this section.
