A BILL

To amend part C of the Balanced Budget and Emergency Deficit Control Act of 1985 to establish a pay-as-yougo requirement for mandatory spending.

- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Mandatory Spending
- 5 Control Act of 2004".
- 6 SEC. 2. EXTENSION OF PAY-AS-YOU-GO REQUIREMENT.
- 7 (a) Purpose.—Section 252(a) of the Balanced
- 8 Budget and Emergency Deficit Control Act of 1985 is
- 9 amended to read as follows:

- 1 "(a) Purpose.—The purpose of this section is to as-
- 2 sure that any legislation that is enacted before October
- 3 1, 2009, that causes a net increase in direct spending will
- 4 trigger an offsetting sequestration.".
- 5 (b) Timing.—Section 252(b)(1) of the Balanced
- 6 Budget and Emergency Deficit Control Act of 1985 is
- 7 amended by striking "any net deficit increase" and all
- 8 that follows through "2002," and by inserting "any net
- 9 increase in direct spending enacted before October 1,
- 10 2009,".
- 11 (c) Calculation of Direct Spending In-
- 12 CREASE.—Section 252(b)(2) of the Balanced Budget and
- 13 Emergency Deficit Control Act of 1985 is amended—
- 14 (1) by striking "deficit" the first place it ap-
- pears and inserting "direct spending";
- 16 (2) in subparagraph (A) by striking "and re-
- ceipts";
- 18 (3) in subparagraph (C) by striking "and re-
- ceipts"; and
- 20 (4) by amending the heading to read as follows:
- 21 "CALCULATION OF DIRECT SPENDING
- 22 INCREASE.—''.
- 23 (d) Conforming Amendments.—(1) The heading
- 24 of section 252(c) of the Balanced Budget and Emergency

- 1 Deficit Control Act of 1985 is amended to read as follows:
- 2 "Eliminating a Direct Spending Increase.—".
- 3 (2) Paragraphs (1), (2), and (4) of section 252(d)
- 4 of the Balanced Budget and Emergency Deficit Control
- 5 Act of 1985 are amended by striking "or receipts" each
- 6 place it appears.
- 7 (3) Section 252(e) of the Balanced Budget and
- 8 Emergency Deficit Control Act of 1985 is amended by
- 9 striking "or receipts" and by striking ", outlays, and re-
- 10 ceipts" and inserting "and outlays".
- 11 (4) Section 254(c)(3) of the Balanced Budget and
- 12 Emergency Deficit Control Act of 1985 is amended—
- (A) in subparagraph (A) by striking "net deficit
- increase or decrease" and by inserting "net increase
- or decrease in direct spending";
- (B) in subparagraph (B) by striking "amount
- of deficit increase or decrease" and by inserting "in-
- 18 crease or decrease in direct spending"; and
- (C) in subparagraph (C) by striking "a deficit
- 20 increase" and by inserting "an increase in direct
- 21 spending".
- 22 SEC. 3. DEFINITION.
- Section 250(c) of the Balanced Budget and Emer-
- 24 gency Deficit Control Act of 1985 is amended by adding
- 25 at the end the following new paragraphs:

1	"(20)(A) Except as provided by subparagraph
2	(B), the term 'emergency requirement' means any
3	provision that provides new budget authority and re-
4	sulting outlays for a situation that poses a threat to
5	life, property, or national security and is—
6	"(i) sudden, quickly coming into being, and
7	not building up over time;
8	"(ii) an urgent, pressing, and compelling
9	need requiring immediate action;
10	"(iii) subject to subparagraph (B), unfore-
11	seen, unpredictable, and unanticipated; and
12	"(iv) not permanent, temporary in nature.
13	"(B) An emergency that is part of an aggregate
14	level of anticipated emergencies, particularly when
15	normally estimated in advance, is not unforeseen.".
16	SEC. 4. EXCEPTION FOR OUTLAY COMPONENTS OF EXPIR-
17	ING RECEIPTS LEGISLATION.
18	Section 252(d)(4) of the Balanced Budget and Emer-
19	gency Deficit Control Act of 1985 is amended by striking
20	"and" at the end of subparagraph (A), by striking the
21	period and inserting "; and" at the end of subparagraph
22	(B), and by adding at the end the following new subpara-
23	graph:
24	"(C) extending provisions in the Economic
25	Growth and Tax Relief Reconciliation Act of

2001 or provisions in sections 101 through 104,
section 202, or sections 301 and 302 of the
Jobs and Growth Tax Relief Reconciliation Act
of 2003.".

- 8 "2006" and inserting "2013".
