Mr. Davis of Florida introduced the following bill; which was referred to the Committee on International Relations

A BILL

To bar certain additional restrictions on travel and remittances to Cuba.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PROHIBITION ON ADDITIONAL RESTRICTIONS
- 4 ON TRAVEL AND REMITTANCES TO CUBA.
- 5 (a) Per-Diem Allowances.—The regulations gov-
- 6 erning travel to Cuba, as in effect on June 15, 2004, may
- 7 not be modified so as to reduce the maximum travel per
- 8 diem rate for persons traveling to Cuba (provided for in
- 9 section 515.560(c)(2) of title 31, Code of Federal Regula-
- 10 tions, as in effect on such date).

- 1 (b) Family Visits to Cuba.—The regulations gov-2 erning travel to Cuba, as in effect on June 15, 2004, may
- 3 not be modified so as to impose additional restrictions on
- 4 such travel for purposes of visiting a close relative who
- 5 is a national of Cuba (provided for in section 515.561 of
- 6 title 31, Code of Federal Regulations, as in effect on such
- 7 date), including by—
- 8 (1) requiring a specific license for such travel;
- 9 (2) limiting the number of trips to fewer than
- one in any 12-month period;
- 11 (3) prohibiting more frequent trips by specific
- license (provided for in section 515.561(b) of title
- 13 31, Code of Federal Regulations, as in effect on
- such date);
- 15 (4) limiting the length of any trip to less than
- 16 30 days; or
- 17 (5) narrowing the definition of "close relative".
- 18 (c) Remittances.—The regulations permitting per-
- 19 sons subject to the jurisdiction of the United States to
- 20 make remittances to households located in Cuba, as in ef-
- 21 fect on June 15, 2004 (provided for in section 515.570
- 22 of title 31, Code of Federal Regulations, as in effect on
- 23 such date), may not be modified so as to impose additional
- 24 restrictions on such remittances, including by limiting the
- 25 recipients of such remittances to close relatives only and

- 1 by reducing the \$3,000 limit for all household remittances
- 2 (provided for in section 515.560(c)(4)(i) of title 31, Code
- 3 of Federal Regulations, as in effect on such date).
- 4 (d) Accompanied Baggage.—The regulations gov-
- 5 erning travel to Cuba, as in effect on June 15, 2004, may
- 6 not be modified so as to limit the amount or weight of
- 7 baggage that may accompany a traveler without specific
- 8 authorization by the United States Government.
