 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Selective Service Reg-
 - 5 istration Termination Act".

1 SEC. 2. TERMINATION OF MILITARY SELECTIVE SERVICE

- 2 ACT REGISTRATION REQUIREMENT.
- 3 (a) REGISTRATION TERMINATION.—Section 17 of the
- 4 Military Selective Service Act (50 U.S.C. App. 467) is
- 5 amended by adding at the end the following new sub-
- 6 section:
- 7 "(d) Termination of Registration Require-
- 8 MENT.—Notwithstanding any other provisions of this title,
- 9 on and after the date of the enactment of the Selective
- 10 Service Registration Termination Act (except in the event
- 11 of a declaration of war by the Congress), no person shall
- 12 be registered for possible induction for training and serv-
- 13 ice in the Armed Forces, including persons who were sub-
- 14 ject to such registration requirements before that date but
- 15 who had not complied with such registration requirements
- 16 by that date.".
- 17 (b) Suspension of Sanctions for Persons Pre-
- 18 VIOUSLY SUBJECT TO REGISTRATION.—Section 12 of
- 19 such Act (50 U.S.C. App. 462) is amended by adding at
- 20 the end the following new subsection:
- 21 "(h) In addition to the exception provided by sub-
- 22 section (g), a person may not be denied a right, privilege,
- 23 benefit, or employment position under Federal law on the
- 24 grounds that the person failed to present himself for and
- 25 submit to registration under section 3 before the date of

- 1 the enactment of the Selective Service Registration Termi-
- 2 nation Act.".
- 3 (c) Suspension of Local Boards, Appeal
- 4 Boards, and Other Selective Service System
- 5 AGENCIES.—Section 10 of such Act (50 U.S.C. App. 460)
- 6 is amended by adding at the end the following new sub-
- 7 section:
- 8 "(i) During any period in which the registration re-
- 9 quirements of section 3 are terminated, the President may
- 10 not appoint a person as a member of a civilian local board,
- 11 civilian appeal board, or similar local agency of the Selec-
- 12 tive Service System and any such board established under
- 13 subsection (b)(3) may not meet.".
