A BILL

Making a supplemental appropriation for the Department of Education for the fiscal year ending September 30, 2004, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "No Child Left Behind
- 5 Appropriations Support Act of 2004".

1 SEC. 2. SUPPLEMENTAL APPROPRIATION.

- 2 (a) APPROPRIATION.—To carry out this Act, out of
- 3 any money in the Treasury not otherwise appropriated,
- 4 there is appropriated \$237,000,000, to remain available
- 5 until expended, for the Department of Education for the
- 6 fiscal year ending September 30, 2004.
- 7 (b) Payments.—In addition to amounts otherwise
- 8 provided to a local educational agency under subpart 2
- 9 of part A of title I of the Elementary and Secondary Edu-
- 10 cation Act of 1965 (20 U.S.C. 6331 et seq.) for fiscal year
- 11 2004, the Secretary of Education shall make a payment
- 12 in an amount determined under subsection (c) to each
- 13 local educational agency that receives a lesser amount of
- 14 funds for fiscal year 2004 under such subpart than the
- 15 agency received for fiscal year 2003.
- 16 (c) Determination of Amount.—The amount of
- 17 a payment to a local educational agency under this Act
- 18 shall be equal to the amount of the difference between—
- (1) the amount the agency would otherwise re-
- 20 ceive for fiscal year 2004 under subpart 2 of part
- A of title I of the Elementary and Secondary Edu-
- 22 cation Act of 1965 (20 U.S.C. 6331 et seq.); and
- 23 (2) the amount the agency received for fiscal
- year 2003 under such subpart.
- 25 (d) Definition.—In this Act, the term "local edu-
- 26 cational agency" has the meaning given to that term in

- 1 section 9101 of the Elementary and Secondary Education
- $2\ \ {\rm Act\ of\ 1965\ (20\ U.S.C.\ 7801)}.$
