A BILL

To amend the Internal Revenue Code of 1986 to impose an excise tax on the termination of retiree prescription drug coverage.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Medicare Corporate
- 5 Accountability Act of 2004".
- 6 SEC. 2. EXCISE TAX ON TERMINATION OF RETIREE PRE-
- 7 SCRIPTION DRUG COVERAGE.
- 8 (a) IN GENERAL.—Chapter 47 of the Internal Rev-
- 9 enue Code of 1986 (relating to certain group health plans)
- 10 is amended by adding at the end the following new section:

1	"SEC. 5000A. TERMINATION OF RETIREE PRESCRIPTION
2	DRUG COVERAGE.
3	"(a) In General.—There is hereby imposed on any
4	employer or employee organization that contributes to a
5	group health plan (as defined in section 5000(b)) a tax
6	on the termination of the provision of prescription drug
7	benefits to any qualified retiree under the plan.
8	"(b) Rate of Tax.—The rate of tax imposed under
9	this section is—
10	"(1) \$750 in the case of a qualified retiree with
11	self-only prescription drug coverage under the plan
12	(determined at the time of the termination of bene-
13	fits), and
14	"(2) \$1,500 in the case of any other qualified
15	retiree.
16	"(c) Qualified Retiree.—For purposes of this sec-
17	tion, the term 'qualified retiree' means any former em-
18	ployee of the employer—
19	"(1) who attained age 65 before the termi-
20	nation of benefits referred to in subsection (a), and
21	"(2) whose employment with the employer ter-
22	minated before the date of the enactment of this sec-
23	tion.
24	"(d) Regulations.—The Secretary may issue regu-
25	lations to carry out the purposes of this section, including

- 1 regulations with respect to the meaning of the terms 'ter-
- 2 mination' and 'prescription drug benefits'.
- 3 "(e) Transfers to Medicare Prescription Drug
- 4 ACCOUNT.—The Secretary shall from time to time trans-
- 5 fer from the the general fund of the Treasury to the Medi-
- 6 care Prescription Drug Account in the Federal Supple-
- 7 mentary Medical Insurance Trust Fund amounts equal to
- 8 the taxes imposed under this section.".
- 9 (b) CLERICAL AMENDMENT.—The table of sections
- 10 for such chapter is amended by adding at the end the fol-
- 11 lowing new item:

"Sec. 5000A. Termination of retiree prescription drug coverage.".

- 12 (c) Effective Date.—The amendments made by
- 13 this section shall apply to terminations of benefits which
- 14 take effect on or after the date of the enactment of this
- 15 Act.
