A BILL

To require the Attorney General and the Secretary of Homeland Security to enter into a memorandum of understanding to guide the integration of the automated fingerprint identification systems of the Federal Bureau of Investigation and the Department of Homeland Security, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Border Security Infor-
- 5 mation Integration Act".

SEC. 2. INTEGRATION OF AUTOMATED FINGERPRINT IDEN-

- 2 TIFICATION SYSTEMS.
- 3 (a) Memorandum of Understanding.—The At-
- 4 torney General and the Secretary of Homeland Security
- 5 shall enter into a memorandum of understanding, not
- 6 later than 3 months after the date of enactment of this
- 7 Act, to guide the integration of the IAFIS system and the
- 8 IDENT system.
- 9 (b) COORDINATION.—The Chief Information Officer
- 10 of the Department of Justice and the Chief Information
- 11 Officer of the Department of Homeland Security shall be
- 12 responsible for coordinating the integration of the IAFIS
- 13 system and the IDENT system.
- 14 (c) Daily Update of the IDENT System.—Until
- 15 the IAFIS system and the IDENT system have been fully
- 16 integrated, as determined by the Chief Information Officer
- 17 of the Department of Justice and the Chief Information
- 18 Officer of the Department of Homeland Security, the
- 19 IDENT system shall be updated on a daily basis with in-
- 20 formation pertaining to warrants issued by the Federal
- 21 Bureau of Investigation and individuals wanted for ques-
- 22 tioning by the Federal Bureau of Investigation.
- 23 (d) Use of Automated Fingerprint Identifica-
- 24 TION SYSTEMS BY A BORDER PATROL AGENT.—The Sec-
- 25 retary of Homeland Security shall develop a clear and uni-
- 26 form policy that details when a border patrol agent shall

- 1 use the IAFIS system and the IDENT system. If a border
- 2 patrol agent uses the IAFIS system or the IDENT system
- 3 with respect to an alien, the border patrol agent shall up-
- 4 date both systems with information pertaining to the
- 5 agent's encounter with the alien.
- 6 (e) Definitions.—For purposes of this section—
- 7 (1) the term "IAFIS system" means the Fed-8 eral Bureau of Investigation's integrated automated 9 fingerprint identification system; and
- 10 (2) the term "IDENT system" means the De-11 partment of Homeland Security's automated biomet-12 ric fingerprint identification system.
