Mr. PAUL (for himself, Mr. GOODE, Mrs. MUSGRAVE, and Mr. DUNCAN) introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To limit the issuance of student and diversity immigrant visas to aliens who are nationals of Saudi Arabia, countries that support terrorism, or countries not cooperating fully with United States antiterrorism efforts.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Terror Immigration
5 Elimination Act of 2003”.

1 **SEC. 2. LIMITATION ON ISSUANCE OF STUDENT AND DIVER-**
2 **SITY IMMIGRANT VISAS TO ALIENS WHO ARE**
3 **NATIONALS OF SAUDI ARABIA OR COUNTRIES**
4 **THAT SUPPORT TERRORISM OR ARE NOT CO-**
5 **OPERATING FULLY WITH UNITED STATES**
6 **ANTITERRORISM EFFORTS.**

7 (a) LIMITATION ON ISSUANCE OF STUDENT VISAS.—
8 Notwithstanding any other provision of law, an alien may
9 not be granted a visa for study in the United States under
10 subparagraphs (F), (J), or (M) of section 101(a)(15) of
11 the Immigration and Nationality Act without review by
12 the President if the alien is a national of Saudi Arabia,
13 a country designated under section 620A of the Foreign
14 Assistance Act of 1961 (22 U.S.C. 2371) as a country
15 that has repeatedly provided support for acts of inter-
16 national terrorism, section 6(j) of the Export Administra-
17 tion Act (50 U.S.C. app. 2405(j)) as a country that sup-
18 ports acts of international terrorism, or section 40A of the
19 Arms Export Control Act (22 U.S.C. 2781) as a country
20 not cooperating fully with United States antiterrorism ef-
21 forts.

22 (d) LIMITATION ON ISSUANCE OF DIVERSITY IMMI-
23 GRANT VISAS.—Notwithstanding any other provision of
24 law, an alien may not be granted an immigrant visa under
25 section 203(c) of the Immigration and Nationality Act (8
26 U.S.C. 1153(c)) relating to diversity immigrants without

1 review by the President if the alien is a national of Saudi
2 Arabia, a country designated under section 620A of the
3 Foreign Assistance Act of 1961 (22 U.S.C. 2371) as a
4 country that has repeatedly provided support for acts of
5 international terrorism, section 6(j) of the Export Admin-
6 istration Act (50 U.S.C. app. 2405(j)) as a country that
7 supports acts of international terrorism, or section 40A
8 of the Arms Export Control Act (22 U.S.C. 2781) as a
9 country not fully cooperating with United States
10 antiterrorism efforts.
