AN ACT

To reauthorize the Temporary Assistance for Needy Families
block grant program through March 31, 2005, and for
other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Welfare Reform Exten-
3 sion Act, Part VIII”.

4 **SEC. 2. EXTENSION OF THE TEMPORARY ASSISTANCE FOR**
5 **NEEDY FAMILIES BLOCK GRANT PROGRAM**
6 **THROUGH MARCH 31, 2005.**

7 (a) IN GENERAL.—Activities authorized by part A of
8 title IV of the Social Security Act, and by sections 510,
9 1108(b), and 1925 of such Act, shall continue through
10 March 31, 2005, in the manner authorized for fiscal year
11 2004, notwithstanding section 1902(e)(1)(A) of such Act,
12 and out of any money in the Treasury of the United States
13 not otherwise appropriated, there are hereby appropriated
14 such sums as may be necessary for such purpose. Grants
15 and payments may be made pursuant to this authority
16 through the second quarter of fiscal year 2005 at the level
17 provided for such activities through the second quarter of
18 fiscal year 2004.

19 (b) CONFORMING AMENDMENTS.—

20 (1) SUPPLEMENTAL GRANTS FOR POPULATION
21 INCREASES IN CERTAIN STATES.—Section
22 403(a)(3)(H)(ii) of the Social Security Act (42
23 U.S.C. 603(a)(3)(H)(ii)) is amended by striking
24 “September 30, 2004” and inserting “March 31,
25 2005”.

1 (2) CONTINGENCY FUND.—Section
 2 403(b)(3)(C)(ii) of such Act (42 U.S.C.
 3 603(b)(3)(C)(ii)) is amended by striking “2004” and
 4 inserting “2005”.

5 (3) MAINTENANCE OF EFFORT.—Section
 6 409(a)(7) of such Act (42 U.S.C. 609(a)(7)) is
 7 amended—

8 (A) in subparagraph (A), by striking “or
 9 2005” and inserting “2005, or 2006”; and

10 (B) in subparagraph (B)(ii), by striking
 11 “2004” and inserting “2005”.

12 **SEC. 3. EXTENSION OF THE NATIONAL RANDOM SAMPLE**
 13 **STUDY OF CHILD WELFARE AND CHILD WEL-**
 14 **FARE WAIVER AUTHORITY THROUGH MARCH**
 15 **31, 2005.**

16 Activities authorized by sections 429A and 1130(a)
 17 of the Social Security Act shall continue through March
 18 31, 2005, in the manner authorized for fiscal year 2004,
 19 and out of any money in the Treasury of the United States
 20 not otherwise appropriated, there are hereby appropriated
 21 such sums as may be necessary for such purpose. Grants
 22 and payments may be made pursuant to this authority
 23 through the second quarter of fiscal year 2005 at the level

- 2 fiscal year 2004.
