## A BILL

To authorize the placement of an equestrian statue depicting frontiersman, explorer, and missionary Jacob Hamblin on the grounds of the Forest Service Kaibab Plateau Visitor Center in Jacob Lake, Arizona, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. PLACEMENT OF EQUESTRIAN STATUE DEPICT-**  
2 **ING JACOB HAMBLIN AT FOREST SERVICE**  
3 **KAIBAB PLATEAU VISITOR CENTER, JACOB**  
4 **LAKE, ARIZONA.**

5 (a) **STATUE AUTHORIZED.**—The Secretary of Agri-  
6 culture shall authorize the Jacob Hamblin Legacy Organi-  
7 zation to install a bronze equestrian statue depicting fron-  
8 tiersman, explorer, and missionary Jacob Hamblin on the  
9 grounds of the Forest Service Kaibab Plateau Visitor Cen-  
10 ter in Jacob Lake, Arizona. The authority to install the  
11 statue includes the authority to provide historical informa-  
12 tion regarding the life of Jacob Hamblin, either as part  
13 of the base of the statue or a nearby display.

14 (b) **LOCATION OF STATUE.**—The statue authorized  
15 by subsection (a) shall be installed in a prominent location  
16 in front of the visitor center so that the statue is visible  
17 from both Highway 67 and Highway 89 Alt.

18 (c) **DESIGN APPROVALS.**—The statue authorized by  
19 subsection (a) shall be at least life size. The actual design  
20 of the statue, and the historical information to be provided  
21 as part of the statue, shall be subject to the approval of  
22 the Secretary.

23 (d) **PROHIBITION ON USE OF FEDERAL FUNDS FOR**  
24 **ESTABLISHMENT.**—No Federal funds may be expended to  
25 design the statue authorized by subsection (a), to acquire

1 the statue, to prepare the site selected for the statue, or  
2 to install the statue.

3 (e) SUSPENSION FOR MISREPRESENTATION IN  
4 FUNDRAISING.—The Secretary may suspend the authority  
5 of the Jacob Hamblin Legacy Organization to place the  
6 statue at the visitor center if the Secretary determines  
7 that fundraising efforts relating to the statue have mis-  
8 represented an affiliation of the Jacob Hamblin Legacy  
9 Organization with the Federal Government.

10 (f) ANNUAL REPORT.—Until the statue authorized  
11 by subsection (a) is installed, the Jacob Hamblin Legacy  
12 Organization shall submit to the Secretary an annual re-  
13 port of operations related to fundraising efforts for the  
14 statue and progress on the placement of the statue at the  
15 visitor center.

16 (g) MAINTENANCE.—Upon installation of the statue  
17 authorized by subsection (a) at the visitor center, the Sec-  
18 retary shall assume responsibility for the maintenance of  
19 the statue. The Secretary may accept contributions for the  
20 maintenance of the statue from the Jacob Hamblin Leg-  
21 acy Organization or other persons. Amounts accepted  
22 under this subsection shall be merged with other funds  
23 available to the Secretary for the operation and mainte-  
24 nance of the visitor center.
