A BILL

To ensure that the right of an individual to display the flag of the United States on residential property not be abridged.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Freedom to Display
- 5 the American Flag Act of 2004".
- 6 SEC. 2. DEFINITIONS.
- 7 For purposes of this Act—
- 8 (1) the term "flag of the United States" has
- 9 the meaning given the term "flag, standard, colors,

1	or ensign" under section 3 of title 4, United States
2	Code;
3	(2) the terms "condominium association" and
4	"cooperative association" have the meanings given
5	such terms under section 604 of Public Law $96-399$
6	(15 U.S.C. 3603);
7	(3) the term "residential real estate manage-
8	ment association" has the meaning given such term
9	under section 528 of the Internal Revenue Code of
10	1986 (26 U.S.C. 528); and
11	(4) the term "member"—
12	(A) as used with respect to a condominium
13	association, means an owner of a condominium
14	unit (as defined under section 604 of Public
15	Law 96–399 (15 U.S.C. 3603)) within such as-
16	sociation;
17	(B) as used with respect to a cooperative
18	association, means a cooperative unit owner (as
19	defined under section 604 of Public Law 96–
20	399 (15 U.S.C. 3603)) within such association;
21	and
22	(C) as used with respect to a residential
23	real estate management association, means an
24	owner of a residential property within a subdivi-
25	sion, development, or similar area subject to

1	any policy or restriction adopted by such asso-
2	ciation.
3	SEC. 3. RIGHT TO DISPLAY THE FLAG OF THE UNITED
4	STATES.
5	A condominium association, cooperative association,
6	or residential real estate management association may not
7	adopt or enforce any policy, or enter into any agreement,
8	that would restrict or prevent a member of the association
9	from displaying the flag of the United States on residen-
10	tial property within the association with respect to which
11	such member has a separate ownership interest or a right
12	to exclusive possession or use.
13	SEC. 4. LIMITATIONS.
14	Nothing in this Act shall be considered to permit any
15	display or use that is inconsistent with—
16	(1) any provision of chapter 1 of title 4, United
17	States Code, or any rule or custom pertaining to the
18	proper display or use of the flag of the United
19	States (as established pursuant to such chapter or
20	any otherwise applicable provision of law); or
21	(2) any reasonable restriction pertaining to the
22	time, place, or manner of displaying the flag of the
23	United States necessary to protect a substantial in-
24	terest of the condominium association, cooperative
