To amend title 40, United States Code, to add Ashtabula, Mahoning, and Trumbull Counties, Ohio, to the Appalachian region.

3 **SECTION 1. ADDITIONS TO APPALACHIAN REGION.**

1           (1) by inserting “Ashtabula,” after “Adams,”;

2           (2) by inserting “Mahoning,” after “Law-  
3       rence,”; and

4           (3) by inserting “Trumbull,” after “Scioto.”

5       **SECTION 1. ADDITIONS TO APPALACHIAN REGION.**

6           (a) *KENTUCKY*.—Section 14102(a)(1)(C) of title 40,  
7       *United States Code*, is amended—

8           (1) by inserting “Nicholas,” after “Morgan,”;  
9       and

10          (2) by inserting “Robertson,” after “Pulaski.”

11          (b) *OHIO*.—Section 14102(a)(1)(H) of such title is  
12       amended—

13          (1) by inserting “Ashtabula,” after “Adams,”;

14          (2) by inserting “Fayette,” after “Coshocton,”;

15          (3) by inserting “Mahoning,” after “Lawrence,”;  
16       and

17          (4) by inserting “Trumbull,” after “Scioto.”

18          (c) *TENNESSEE*.—Section 14102(a)(1)(K) of such title  
19       is amended—

20          (1) by inserting “Giles,” after “Franklin,”; and

21          (2) by inserting “Lawrence, Lewis, Lincoln,”  
22       after “Knox.”

23          (d) *VIRGINIA*.—Section 14102(a)(1)(L) of such title is  
24       amended—

25          (1) by inserting “Henry,” after “Grayson,”; and

1           (2) by inserting “Patrick,” after “Montgomery.”

2   **SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

3           Section 14703(a) of title 40, United States Code, is  
4   amended by striking paragraphs (1) through (3) and insert-  
5   ing the following:

6           “(1) \$88,000,000 for each of fiscal years 2002  
7           and 2003.

8           “(2) \$91,000,000 for fiscal year 2004.

9           “(3) \$93,000,000 for fiscal year 2005.

10          “(4) \$95,000,000 for fiscal year 2006.”.

Amend the title so as to read: “A bill to amend title 40, United States Code, to make additions to the Appalachian region, and for other purposes.”.
