A BILL

To render all enrolled members of the Tohono O’odham Nation citizens of the United States as of the date of their enrollment and to recognize the valid membership credential of the Tohono O’odham Nation as the legal

equivalent of a certificate of citizenship or a State-issued birth certificate for all Federal purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Tohono O’odham Citi-
 5 zenship Act of 2003”.

6 **SEC. 2. NATURALIZATION FOR TOHONO O’ODHAM.**

7 (a) IN GENERAL.—Chapter 2 of title III of the Immi-
 8 gration and Nationality Act (8 U.S.C. 1421 et seq.) is
 9 amended by inserting after section 322 the following:

10 “ENROLLED MEMBERS OF TOHONO O’ODHAM NATION

11 “SEC. 323. (a) GRANTING OF CITIZENSHIP.—A per-
 12 son who is listed on the official membership roll of the
 13 Tohono O’odham Nation, a federally recognized American
 14 Indian nation located in Arizona, is a citizen of the United
 15 States as of the date on which such listing occurs.

16 “(b) NO DERIVATIVE BENEFITS TO RELATIVES.—
 17 Nothing in this section shall be construed as providing for
 18 any benefit under this Act for any spouse, son, daughter,
 19 or other relative of a person granted citizenship under this
 20 section.”.

21 (b) CLERICAL AMENDMENT.—The table of contents
 22 of the Immigration and Nationality Act is amended by in-

1 serting after the item relating to section 322 the following
 2 new item:

“Sec. 323. Enrolled members of Tohono O’odham Nation.”.

3 **SEC. 3. TREATMENT OF TRIBAL MEMBERSHIP CREDEN-**
 4 **TIAL.**

5 Notwithstanding any other provision of law, the valid
 6 membership credential issued to a person who is listed on
 7 the official membership roll of the Tohono O’odham Na-
 8 tion pursuant to the laws of the Tohono O’odham Nation
 9 shall be considered, for all purposes subject to Federal
 10 law, equivalent to—

11 (1) a certificate of citizenship issued under sec-
 12 tion 341(a) of the Immigration and Nationality Act
 13 (8 U.S.C. 1452(a)) to persons who satisfy the re-
 14 quirements of such section; and

15 (2) a State-issued birth certificate.
