## RESOLUTION

Providing amounts for the expenses of the Committee on  
Homeland Security in the One Hundred Eighth Congress.

1       *Resolved,*

2       **SECTION 1. AMOUNTS FOR COMMITTEE EXPENSES.**

3       ~~For the expenses of the Committee on Homeland Se-~~  
4       ~~curity (hereafter in this resolution referred to as the~~  
5       ~~“Committee”), including the expenses of all staff salaries,~~

1 there shall be paid, out of the applicable accounts of the  
2 House of Representatives for committee salaries and ex-  
3 penses, not more than \$11,028,787 for the One Hundred  
4 Eighth Congress.

5 **SEC. 2. SESSION LIMITATIONS.**

6 Of the amount specified in section 1—

7 (1) not more than \$5,657,656 shall be available  
8 for expenses incurred during the period beginning at  
9 noon on January 3, 2003, and ending immediately  
10 before noon on January 3, 2004; and

11 (2) not more than \$5,371,131 shall be available  
12 for expenses incurred during the period beginning at  
13 noon on January 3, 2004, and ending immediately  
14 before noon on January 3, 2005.

15 **SEC. 3. VOUCHERS.**

16 Payments under this resolution shall be made on  
17 vouchers authorized by the Committee, signed by the  
18 Chairman of the Committee, and approved in the manner  
19 directed by the Committee on House Administration.

20 **SEC. 4. REGULATIONS.**

21 Amounts made available under this resolution shall  
22 be expended in accordance with regulations prescribed by  
23 the Committee on House Administration.

1 **SECTION 1. EXPENSES FOR THE SELECT COMMITTEE ON**  
2 **HOMELAND SECURITY FOR THE ONE HUN-**  
3 **DRED EIGHTH CONGRESS.**

4 *With respect to the One Hundred Eighth Congress,*  
5 *there shall be paid out of the applicable accounts of the*  
6 *House of Representatives, in accordance with this primary*  
7 *expense resolution, not more than \$10,952,787 for the ex-*  
8 *penses (including the expenses of all staff salaries) of the*  
9 *Select Committee on Homeland Security.*

10 **SEC. 2. FIRST SESSION LIMITATION.**

11 *Of the amount provided for in section 1, not more than*  
12 *\$5,366,866 shall be available for expenses incurred during*  
13 *the period beginning at noon on January 3, 2003, and end-*  
14 *ing immediately before noon on January 3, 2004.*

15 **SEC. 3. SECOND SESSION LIMITATION.**

16 *Of the amount provided for in section 1, not more than*  
17 *\$5,585,921 shall be available for expenses incurred during*  
18 *the period beginning at noon on January 3, 2004, and end-*  
19 *ing immediately before noon on January 3, 2005.*

20 **SEC. 4. VOUCHERS.**

21 *Payments under this resolution shall be made on*  
22 *vouchers authorized by the Select Committee on Homeland*  
23 *Security, signed by the chairman of such Committee, and*  
24 *approved in the manner directed by the Committee on*  
25 *House Administration.*

1 **SEC. 5. REGULATIONS.**

2 *Amounts made available under this resolution shall be*  
3 *expended in accordance with regulations prescribed by the*  
4 *Committee on House Administration.*

5 **SEC. 6. ADJUSTMENT AUTHORITY.**

6 *The Committee on House Administration shall have*  
7 *authority to make adjustments in the amount under section*  
8 *1, if necessary to comply with an order of the President*  
9 *issued under section 254 of the Balanced Budget and Emer-*  
10 *gency Deficit Control Act of 1985 or to conform to any re-*  
11 *duction in appropriations for the purposes of such section*  
12 *1.*
