## RESOLUTION

Providing for the expenses of certain committees of the  
House of Representatives in the One Hundred Eighth  
Congress.

1       *Resolved,*

2       **SECTION 1. COMMITTEE EXPENSES FOR THE ONE HUN-**  
3               **DRED EIGHTH CONGRESS.**

4           (a) IN GENERAL.—With respect to the One Hundred  
5 Eighth Congress, there shall be paid out of the applicable  
6 accounts of the House of Representatives, in accordance  
7 with this primary expense resolution, not more than the  
8 amount specified in subsection (b) for the expenses (in-  
9 cluding the expenses of all staff salaries) of each com-  
10 mittee named in subsection.

1 (b) COMMITTEES AND AMOUNTS.—The committees  
2 and amounts referred to in subsection (a) are: Committee  
3 on Agriculture, \$10,623,640; Committee on Armed Serv-  
4 ices, \$12,377,680; Committee on the Budget,  
5 \$11,869,572; Committee on Education and the Workforce,  
6 \$14,922,183; Committee on Energy and Commerce,  
7 \$19,117,623; Committee on Financial Services,  
8 \$16,995,487; Committee on Government Reform,  
9 \$20,400,000; Committee on Homeland Security,

11 \$10,374,974; Permanent Select Committee on Intel-

22 **SEC. 2. FIRST SESSION LIMITATIONS.**

23 (a) IN GENERAL.—Of the amount provided for in  
24 section 1 for each committee named in subsection (b), not  
25 more than the amount specified in such subsection shall

1 be available for expenses incurred during the period begin-  
2 ning at noon on January 3, 2003, and ending immediately  
3 before noon on January 3, 2004.

4 (b) COMMITTEES AND AMOUNTS.—The committees

23 **SEC. 3. SECOND SESSION LIMITATIONS.**

24 (a) IN GENERAL.—Of the amount provided for in  
25 section 1 for each committee named in subsection (b), not

1 more than the amount specified in such subsection shall  
2 be available for expenses incurred during the period begin-  
3 ning at noon on January 3, 2004, and ending immediately  
4 before noon on January 3, 2005.

5 (b) COMMITTEES AND AMOUNTS.—The committees  
6 and amounts referred to in subsection (a) are: Committee  
7 on Agriculture, \$5,331,415; Committee on Armed Serv-  
8 ices, \$6,434,005; Committee on the Budget, \$5,975,554;  
9 Committee on Education and the Workforce, \$7,523,946;  
10 Committee on Energy and Commerce, \$9,731,721; Com-  
11 mittee on Financial Services, \$8,851,207; Committee on  
12 Government Reform, \$10,400,000; Committee on Home-  
13 land Security, \$5,371,131; Committee on House Adminis-  
14 tration, \$5,346,401; Permanent Select Committee on In-  
15 telligence, \$4,036,163; Committee on International Rela-  
16 tions, \$8,344,746; Committee on the Judiciary,  
17 \$8,825,346; Committee on Resources, \$7,549,963; Com-  
18 mittee on Rules, \$2,852,979; Committee on Science,

1 **SEC. 4. VOUCHERS.**

2       Payments under this resolution shall be made on  
3 vouchers authorized by the committee involved, signed by  
4 the chairman of such committee, and approved in the  
5 manner directed by the Committee on House Administra-  
6 tion.

7 **SEC. 5. REGULATIONS.**

8       Amounts made available under this resolution shall  
9 be expended in accordance with regulations prescribed by  
10 the Committee on House Administration.

11 **SEC. 6. ADJUSTMENT AUTHORITY.**

12       The Committee on House Administration shall have  
13 authority to make adjustments in amounts under section  
14 1, if necessary to comply with an order of the President  
15 issued under section 254 of the Balanced Budget and  
16 Emergency Deficit Control Act of 1985 or to conform to  
17 any reduction in appropriations for the purposes of such  
18 section 1.
