## RESOLUTION

Expressing concern for the status of the Assyrian people  
in post-war Iraq.

Whereas the Assyrian Empire was a kingdom in northern Mesopotamia, located in what is now northern Iraq and southeastern Turkey;

Whereas the Assyrian people are a distinct cultural and ethnic group, tracing their heritage back over 6,700 years;

Whereas the Assyrians have made significant and invaluable contributions to the progress of human civilization;

Whereas the Assyrian language is a unique and living language, with its roots in ancient Akkadian;

Whereas the Assyrian people have suffered profound religious and ethnic discrimination by the Iraqi government under Saddam Hussein;

Whereas the Assyrian people have made great sacrifices in the effort to oppose the oppressive regime of Saddam Hussein in Iraq and have suffered greatly as a result of their efforts;

Whereas the rapid disintegration of Iraq's armed forces at the conclusion of Operation Iraqi Freedom created a vacuum in authority and security for the people of Iraq;

Whereas the Assyrian people have been repeatedly denied their right as a nation to determine their own destiny; and

Whereas the Assyrian people have expressed their desire to coexist peacefully with other peoples in a democratic Iraq: Now, therefore, be it

1       *Resolved*, That it is the Sense of the House of Rep-  
2       resentatives that—

3               (1) Assyrians should be entitled to freely prac-  
4       tice their religion and customs, speak their language,  
5       and celebrate their culture in Iraq;

6               (2) Assyrian leaders in Iraq should be consulted  
7       and included in discussions regarding the composi-  
8       tion of the future government of Iraq;

9               (3) the President should call for the future gov-  
10      ernment of Iraq to uphold the rights of Assyrians;

11              (4) the President should instruct the Secretary  
12      of State to consider the concerns and rights of As-

1       syrians through the appropriate bilateral and  
2       mulilateral forums as debate over post-war Iraq con-  
3       tinues; and

4           (5) the President should instruct the United  
5       States Ambassador to the United Nations to work in  
6       that international organization to ensure that the  
7       rights and concerns of Assyrians in Iraq are consid-  
8       ered as debate over post-war Iraq continues.
