Mr. LINDER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2765) making appropriations for the government of the District of Columbia and other activities chargeable in whole or in part against the revenues of said District for the fiscal year ending September 30, 2004, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2765) making appropriations for

1 the government of the District of Columbia and other ac-
2 tivities chargeable in whole or in part against the revenues
3 of said District for the fiscal year ending September 30,
4 2004, and for other purposes. The first reading of the bill
5 shall be dispensed with. All points of order against consid-
6 eration of the bill are waived. General debate shall be con-
7 fined to the bill and shall not exceed one hour equally di-
8 vided and controlled by the chairman and ranking minor-
9 ity member of the Committee on Appropriations. After
10 general debate the bill shall be considered for amendment
11 under the five-minute rule. Points of order against provi-
12 sions in the bill for failure to comply with clause 2 of rule
13 XXI are waived except as follows: beginning with “: Pro-
14 vide” on page 36, line 25 through page 37, line 3; page
15 37, line 13, through page 38, line 2; page 39, line 23,
16 through page 41, line 14; page 42, line 23, through page
17 43, line 14. Where points of order are waived against part
18 of a section, points of order against a provision in another
19 part of such section may be made only against such provi-
20 sion and not against the entire section. The amendment
21 printed in the report of the Committee on Rules accom-
22 panying this resolution may be offered only by a Member
23 designated in the report and only at the appropriate point
24 in the reading of the bill, shall be considered as read, shall
25 be debatable for the time specified in the report equally

1 divided and controlled by the proponent and an opponent,
2 shall not be subject to amendment, and shall not be sub-
3 ject to a demand for division of the question in the House
4 or in the Committee of the Whole. All points of order
5 against the amendment are waived. During consideration
6 of the bill for amendment, the Chairman of the Committee
7 of the Whole may accord priority in recognition on the
8 basis of whether the Member offering an amendment has
9 caused it to be printed in the portion of the Congressional
10 Record designated for that purpose in clause 8 of rule
11 XVIII. Amendments so printed shall be considered as
12 read. After a motion that the Committee rise has been
13 rejected on a legislative day, the Chairman may entertain
14 another such motion on that day only if offered by the
15 chairman of the Committee on Appropriations or the Ma-
16 jority Leader or a designee. After a motion to strike out
17 the enacting words of the bill (as described in clause 9
18 of rule XVIII) has been rejected, the Chairman may not
19 entertain another such motion during further consider-
20 ation of the bill. At the conclusion of consideration of the
21 bill for amendment the Committee shall rise and report
22 the bill to the House with such amendments as may have
23 been adopted. The previous question shall be considered
24 as ordered on the bill and amendments thereto to final

- 1 passage without intervening motion except one motion to
- 2 recommit with or without instructions.
