Mr. DREIER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for further consideration of the bill (H.R. 3550) to authorize funds for Federal-aid highways, highway safety programs, and transit programs, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for further
5 consideration of the bill (H.R. 3550) to authorize funds
6 for Federal-aid highways, highway safety programs, and

1 transit programs, and for other purposes. No further gen-
2 eral debate (except for the final period contemplated in
3 the order of the House of March 30, 2004) shall be in
4 order. The amendment in the nature of a substitute rec-
5 ommended by the Committee on Transportation and In-
6 frastructure now printed in the bill, modified by the
7 amendments printed in part A of the report of the Com-
8 mittee on Rules accompanying this resolution, shall be
9 considered as adopted in the House and in the Committee
10 of the Whole. The bill, as amended, shall be considered
11 as the original bill for the purpose of further amendment
12 under the five-minute rule and shall be considered as read.
13 All points of order against provisions in the bill, as amend-
14 ed, are waived. No further amendment shall be in order
15 except those printed in part B of the report of the Com-
16 mittee on Rules. Each further amendment may be offered
17 only in the order printed in the report, may be offered
18 only by a Member designated in the report, shall be con-
19 sidered as read, shall be debatable for the time specified
20 in the report equally divided and controlled by the pro-
21 ponent and an opponent, and shall not be subject to
22 amendment or demand for division of the question. All
23 points of order against such further amendments are
24 waived. At the conclusion of consideration of the bill, as
25 amended, the Committee shall rise and report the bill, as

1 amended, to the House with such further amendments as
2 may have been adopted. The previous question shall be
3 considered as ordered on the bill and amendments thereto
4 to final passage without intervening motion except one
5 motion to recommit with or without instructions.

6 SEC. 2. The amendment considered as adopted under
7 the first section of this resolution shall be considered an
8 amendment offered under section 411 of House Concur-
9 rent Resolution 95.
