3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Title I Integrity Act5 of 2003".

6 SEC. 2. DIRECT AND INDIRECT INSTRUCTIONAL SERVICES.

7 Subpart 1 of part A of title I of the Elementary and
8 Secondary Education Act of 1965 (20 U.S.C. 6311 et
9 seq.) is amended by adding at the end the following:

3 "(a) IN GENERAL.—

4 "(1) USE OF FUNDS.—Notwithstanding any 5 other provision of this Act, a local educational agen-6 cy shall use funds received under this subpart only 7 for direct instructional services and indirect instructional services. 8 9 "(2) Limitation on indirect instructional 10 SERVICES.—A local educational agency may not use 11 more than 10 percent of funds received under this 12 subpart for indirect instructional services. "(b) INSTRUCTIONAL SERVICES.— 13 "(1) DIRECT INSTRUCTIONAL SERVICES.—In 14 this section, the term 'direct instructional services' 15 16 means-"(A) the implementation of instructional 17 18 interventions and corrective actions to improve 19 student achievement; 20 "(B) the extension of academic instruction 21 beyond the normal school day and year, includ-22 ing during summer school;
