A BILL

- To amend part D of title XVIII of the Social Security Act to strike the language that prohibits the Secretary of Health and Human Services from negotiating prices for prescription drugs furnished under the Medicare program.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Efficiency in Govern-
 - 5 ment Health Care Spending Act".
 - 6 SEC. 2. FINDINGS.
 - 7 Congress makes the following findings:

1	(1) Prohibiting the Federal Government from
2	negotiating prescription drug prices with manufac-
3	turers fails to take advantage of the purchasing
4	power of the Medicare program.
5	(2) Negotiating prescription drug prices can re-
6	duce the costs of prescription drugs for both the
7	Medicare program and taxpayers.
8	(3) A 2002 study by the inspector general of
9	the Department of Health and Human Services
10	found that—
11	(A) both the Medicare program and the
12	beneficiaries of the Medicare program contin-
13	ually pay too much for medical equipment and
14	medical supplies; and
15	(B) if the Medicare program paid the same
16	prices for 16 health care supplies as the De-
17	partment of Veterans Affairs, which directly ne-
18	gotiates prices with manufacturers, pays for
19	those supplies, the Federal Government could
20	save \$958,000,000 each year.
21	SEC. 3. ELIMINATION OF PROHIBITION OF NEGOTIATION
22	OF PRICES.
23	(a) Repeal of Noninterference Provision.—
24	(1) In general.—Subsection (i) of section
25	1860D-11 of the Social Security Act, as added by

- 1 section 101 of the Medicare Prescription Drug, Im-
- 2 provement, and Modernization Act of 2003, is re-
- 3 pealed.
- 4 (2) Conforming amendment.—Subsection (j)
- 5 of section 1860D–11 of the Social Security Act, as
- 6 added by section 101 of the Medicare Prescription
- 7 Drug, Improvement, and Modernization Act of 2003,
- 8 is redesignated as subsection (i).
- 9 (b) Effective Date.—The amendments made by
- 10 this section shall take effect as if included in the enact-
- 11 ment of section 101 of the Medicare Prescription Drug,
- 12 Improvement, and Modernization Act of 2003.
