- 2 striking "18 months after the date of the enactment of
- 3 this Act" and inserting "January 10, 2005".
- 4 (b) Additional Funding.—Section 611 of that Act
- 5 (6 U.S.C. 101 note; 116 Stat. 2413) is amended—
- 6 (1) by redesignating subsection (b) as sub-
- 7 section (c);
- 8 (2) by inserting after subsection (a) the fol-
- 9 lowing new subsection (b):
- 10 "(b) Additional Funding From the National
- 11 Foreign Intelligence Program.—In addition to the
- 12 amounts made available to the Commission under sub-
- 13 section (a), of the amounts authorized to be appropriated
