2	CINE-ELIGIBLE CHILD.

5	is amended by striking "or a rural health clinic (as defined

14	SEC. 3. REPEAL OF PRICE CAP FOR PRE-1993 VACCINES.
15	(a) In General.—Section 1928(d)(3)(B) of the So-
16	cial Security Act (42 U.S.C. 1396s(d)(3)(B)) is repealed.
17	(b) Conforming Amendment.—Section 1928(d)(3)
18	of such Act (42 U.S.C. 1396s(d)(3)) is amended by strik-
19	ing subparagraph (C) and inserting the following:
20	"(B) Negotiation of discounted
21	PRICE.—With respect to contracts entered into
22	for a pediatric vaccine described in this section,

- 4 ond sentence the following: "The Secretary may sell such
- 5 quantities of vaccines from such supply to public health
- 6 departments or back to the vaccine manufacturer as the
- 7 Secretary determines appropriate. Proceeds received from
- 8 such sales shall be available to the Secretary only for the
- 9 purpose of procuring pediatric vaccines stockpiles under
- 10 this section and shall remain available until expended.".
