A BILL

To reauthorize the Museum and Library Services Act, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Museum and Library
5 Services Act of 2003”.

1 **TITLE I—GENERAL PROVISIONS**

2 **SEC. 101. GENERAL DEFINITIONS.**

3 Section 202 of the Museum and Library Services Act

4 (20 U.S.C. 9101) is amended—

5 (1) by striking paragraphs (1) and (4);

6 (2) by redesignating paragraph (2) as para-

7 graph (1);

1 (3) by inserting after paragraph (1), as redesignated by paragraph (2) of this section, the following:

2 “(2) INDIAN TRIBE.—The term ‘Indian tribe’
3 means any tribe, band, nation, or other organized
4 group or community, including any Alaska native
5 village, regional corporation, or village corporation,
6 as defined in or established pursuant to the Alaska
7 Native Claims Settlement Act (43 U.S.C. 1601 et
8 seq.), which is recognized by the Secretary of the In-
9 terior as eligible for the special programs and serv-
10 ices provided by the United States to Indians be-
11 cause of their status as Indians.”; and

12 (4) by adding at the end the following:

13 “(4) MUSEUM AND LIBRARY SERVICES
14 BOARD.—The term ‘Museum and Library Services
15 Board’ means the National Museum and Library
16 Services Board established under section 207.”.

17 **SEC. 102. INSTITUTE OF MUSEUM AND LIBRARY SERVICES.**

18 Section 203 of the Museum and Library Services Act
19 (20 U.S.C. 9102) is amended—

20 (1) in subsection (b), by striking the last sen-
21 tence; and

22 (2) by adding at the end the following:

23 “(c) MUSEUM AND LIBRARY SERVICES BOARD.—
24 There shall be a National Museum and Library Services
25

1 Board within the Institute, as provided under section
2 207.”.

3 **SEC. 103. DIRECTOR OF THE INSTITUTE.**

4 Section 204 of the Museum and Library Services Act
5 (20 U.S.C. 9103) is amended—

6 (1) in subsection (e), by adding at the end the
7 following: “Where appropriate, the Director shall en-
8 sure that activities under subtitle B are coordinated
9 with activities under section 1251 of the Elementary
10 and Secondary Education Act of 1965 (20 U.S.C.
11 6383).”; and

12 (2) by adding at the end the following:

13 “(f) REGULATORY AUTHORITY.—The Director may
14 promulgate such rules and regulations as are necessary
15 and appropriate to implement the provisions of this title.”.

16 **SEC. 104. NATIONAL MUSEUM AND LIBRARY SERVICES**
17 **BOARD.**

18 The Museum and Library Services Act (20 U.S.C.
19 9101 et seq.) is amended—

20 (1) by redesignating section 207 as section 208;
21 and

22 (2) by inserting after section 206 the following:

1 **“SEC. 207. NATIONAL MUSEUM AND LIBRARY SERVICES**

2 **BOARD.**

3 “(a) ESTABLISHMENT.—There is established in the
4 Institute a board to be known as the ‘National Museum
5 and Library Services Board’.

6 “(b) MEMBERSHIP.—

7 “(1) NUMBER AND APPOINTMENT.—The Mu-
8 seum and Library Services Board shall be composed
9 of the following:

10 “(A) The Director.

11 “(B) The Deputy Director for the Office of
12 Library Services.

13 “(C) The Deputy Director for the Office of
14 Museum Services.

15 “(D) The Chairman of the National Com-
16 mission on Libraries and Information Science.

17 “(E) 10 members appointed by the Presi-
18 dent, by and with the advice and consent of the
19 Senate, from among individuals who are citi-
20 zens of the United States and who are specially
21 qualified in the area of library services by virtue
22 of their education, training, or experience.

23 “(F) 11 members appointed by the Presi-
24 dent, by and with the advice and consent of the
25 Senate, from among individuals who are citi-
26 zens of the United States and who are specially

1 qualified in the area of museum services by vir-
 2 tue of their education, training, or experience.

3 “(2) SPECIAL QUALIFICATIONS.—

4 “(A) LIBRARY MEMBERS.—Of the mem-
 5 bers of the Museum and Library Services
 6 Board appointed under paragraph (1)(E)—

7 “(i) 5 shall be professional librarians
 8 or information specialists, of whom—

9 “(I) not less than 1 shall be
 10 knowledgeable about electronic infor-
 11 mation and technical aspects of li-
 12 brary and information services and
 13 sciences; and

14 “(II) not less than 1 shall be
 15 knowledgeable about the library and
 16 information service needs of under-
 17 served communities; and

18 “(ii) the remainder shall have special
 19 competence in, or knowledge of, the needs
 20 for library and information services in the
 21 United States.

22 “(B) MUSEUM MEMBERS.—Of the mem-
 23 bers of the Museum and Library Services
 24 Board appointed under paragraph (1)(F)—

1 “(i) 5 shall be museum professionals
2 who are or have been affiliated with—

3 “(I) resources that, collectively,
4 are broadly representative of the cura-
5 torial, conservation, educational, and
6 cultural resources of the United
7 States; or

8 “(II) museums that, collectively,
9 are broadly representative of various
10 types of museums, including museums
11 relating to science, history, tech-
12 nology, art, zoos, botanical gardens,
13 and museums designed for children;
14 and

15 “(ii) the remainder shall be individ-
16 uals recognized for their broad knowledge,
17 expertise, or experience in museums or
18 commitment to museums.

19 “(3) GEOGRAPHIC AND OTHER REPRESENTA-
20 TION.—Members of the Museum and Library Serv-
21 ices Board shall be appointed to reflect individuals
22 from various geographic regions of the United
23 States. The Museum and Library Services Board
24 may not include, at any time, more than 3 appoint-
25 ive members from a single State. In making such

1 appointments, the President shall give due regard to
 2 equitable representation of women, minorities, and
 3 persons with disabilities who are involved with muse-
 4 ums and libraries.

5 “(4) VOTING.—The Director, the Deputy Direc-
 6 tor of the Office of Library Services, and the Deputy
 7 Director of the Office of Museum Services shall be
 8 nonvoting members of the Museum and Library
 9 Services Board.

10 “(c) TERMS.—

11 “(1) IN GENERAL.—Except as otherwise pro-
 12 vided in this subsection, each member of the Mu-
 13 seum and Library Services Board appointed under
 14 subparagraph (E) or (F) of subsection (b)(1) shall
 15 serve for a term of 5 years.

16 “(2) INITIAL BOARD APPOINTMENTS.—

17 “(A) TREATMENT OF MEMBERS SERVING
 18 ON EFFECTIVE DATE.—Notwithstanding sub-
 19 section (b), each individual who is a member of
 20 the National Museum Services Board on the
 21 day before the date of enactment of the Mu-
 22 seum and Library Services Act of 2003, may,
 23 at the individual’s election, complete the bal-
 24 ance of the individual’s term as a member of
 25 the Museum and Library Services Board.

“(B) FIRST APPOINTMENTS.—Notwithstanding subsection (b), any appointive vacancy in the initial membership of the Museum and Library Services Board existing after the application of subparagraph (A), and any vacancy in such membership subsequently created by reason of the expiration of the term of an individual described in subparagraph (A), shall be filled by the appointment of a member described in subsection (b)(1)(E). When the Museum and Library Services Board consists of an equal number of individuals who are specially qualified in the area of library services and individuals who are specially qualified in the area of museum services, this subparagraph shall cease to be effective and the members of the Museum and Library Services Board shall be appointed in accordance with subsection (b).

“(C) AUTHORITY TO ADJUST TERMS.—The terms of the first members appointed to the Museum and Library Services Board shall be adjusted by the President as necessary to ensure that the terms of not more than 4 members expire in the same year. Such adjustments

1 shall be carried out through designation of the
2 adjusted term at the time of appointment.

3 “(3) VACANCIES.—Any member appointed to
4 fill a vacancy shall serve for the remainder of the
5 term for which the predecessor of the member was
6 appointed.

7 “(4) REAPPOINTMENT.—No appointive member
8 of the Museum and Library Services Board who has
9 been a member for more than 7 consecutive years
10 shall be eligible for reappointment.

11 “(5) SERVICE UNTIL SUCCESSOR TAKES OF-
12 FICE.—Notwithstanding any other provision of this
13 subsection, an appointive member of the Museum
14 and Library Services Board shall serve after the ex-
15 piration of the term of the member until the suc-
16 cessor to the member takes office.

17 “(d) DUTIES AND POWERS.—

18 “(1) IN GENERAL.—The Museum and Library
19 Services Board shall advise the Director on general
20 policies with respect to the duties, powers, and au-
21 thority of the Institute relating to museum and li-
22 brary services, including financial assistance award-
23 ed under this title.

1 “(2) NATIONAL AWARDS.—The Museum and
2 Library Services Board shall assist the Director in
3 making awards under section 209.

4 “(e) CHAIRPERSON.—The Director shall serve as
5 Chairperson of the Museum and Library Services Board.

6 “(f) MEETINGS.—

7 “(1) IN GENERAL.—The Museum and Library
8 Services Board shall meet not less than 2 times each
9 year and at the call of the Director.

10 “(2) VOTE.—All decisions by the Museum and
11 Library Services Board with respect to the exercise
12 of its duties and powers shall be made by a majority
13 vote of the members of the Board who are present
14 and authorized to vote.

15 “(g) QUORUM.—A majority of the voting members of
16 the Museum and Library Services Board shall constitute
17 a quorum for the conduct of business at official meetings,
18 but a lesser number of members may hold hearings.

19 “(h) COMPENSATION AND TRAVEL EXPENSES.—

20 “(1) COMPENSATION.—Each member of the
21 Museum and Library Services Board who is not an
22 officer or employee of the Federal Government may
23 be compensated at a rate to be fixed by the Presi-
24 dent, but not to exceed the daily equivalent of the
25 maximum annual rate of pay authorized for a posi-

1 tion above grade GS–15 of the General Schedule
 2 under section 5108 of title 5, United States Code,
 3 for each day (including travel time) during which
 4 such member is engaged in the performance of the
 5 duties of the Museum and Library Services Board.
 6 Members of the Museum and Libraries Services
 7 Board who are full-time officers or employees of the
 8 Federal Government may not receive additional pay,
 9 allowances, or benefits by reason of their service on
 10 the Board.

11 “(2) TRAVEL EXPENSES.—Each member of the
 12 Museum and Library Services Board shall receive
 13 travel expenses, including per diem in lieu of subsist-
 14 ence, in accordance with applicable provisions under
 15 subchapter I of chapter 57 of title 5, United States
 16 Code.

17 “(i) COORDINATION.—The Director, with the advice
 18 of the Museum and Library Services Board, shall take
 19 steps to ensure that the policies and activities of the Insti-
 20 tute are coordinated with other activities of the Federal
 21 Government.”.

22 **SEC. 105. AWARDS; ANALYSIS OF IMPACT OF SERVICES.**

23 The Museum and Library Services Act (20 U.S.C.
 24 9101 et seq.) is amended by inserting after section 208
 25 (as redesignated by section 104 of this Act) the following:

1 **“SEC. 209. AWARDS.**

2 “The Director, with the advice of the Museum and
3 Library Services Board, may annually award National
4 Awards for Library Service and National Awards for Mu-
5 seum Service to outstanding libraries and outstanding mu-
6 seums, respectively, that have made significant contribu-
7 tions in service to their communities.

8 **“SEC. 210. ANALYSIS OF IMPACT OF MUSEUM AND LIBRARY**
9 **SERVICES.**

10 “From amounts appropriated under sections 214(c)
11 and 274(b), the Director shall carry out and publish anal-
12 yses of the impact of museum and library services. Such
13 analyses—

14 “(1) shall be conducted in ongoing consultation
15 with—

16 “(A) State library administrative agencies;

17 “(B) State, regional, and national library
18 and museum organizations; and

19 “(C) other relevant agencies and organiza-
20 tions;

21 “(2) shall identify national needs for, and
22 trends of, museum and library services provided with
23 funds made available under subtitles B and C;

24 “(3) shall report on the impact and effective-
25 ness of programs conducted with funds made avail-
26 able by the Institute in addressing such needs; and

1 “(4) shall identify, and disseminate information
2 on, the best practices of such programs to the agen-
3 cies and entities described in paragraph (1).”.

4 **TITLE II—LIBRARY SERVICES**
5 **AND TECHNOLOGY**

6 **SEC. 201. PURPOSE.**

7 Section 212 of the Library Services and Technology
8 Act (20 U.S.C. 9121) is amended by striking paragraphs
9 (2) through (5) and inserting the following:

10 “(2) to promote improvement in library services
11 in all types of libraries in order to better serve the
12 people of the United States;

13 “(3) to facilitate access to resources in all types
14 of libraries for the purpose of cultivating an edu-
15 cated and informed citizenry; and

16 “(4) to encourage resource sharing among all
17 types of libraries for the purpose of achieving eco-
18 nomical and efficient delivery of library services to
19 the public.”.

20 **SEC. 202. DEFINITIONS.**

21 Section 213 of the Library Services and Technology
22 Act (20 U.S.C. 9122) is amended—

23 (1) by striking paragraph (1); and

1 (2) by redesignating paragraphs (2), (3), (4),
 2 (5), and (6) as paragraphs (1), (2), (3), (4), and
 3 (5), respectively.

4 **SEC. 203. AUTHORIZATION OF APPROPRIATIONS.**

5 Section 214 of the Library Services and Technology
 6 Act (20 U.S.C. 9123) is amended—

7 (1) by amending subsection (a) to read as fol-
 8 lows:

9 “(a) IN GENERAL.—There are authorized to be ap-
 10 propriated to carry out this subtitle \$350,000,000 for fis-
 11 cal year 2004 and such sums as may be necessary for fis-
 12 cal years 2005 through 2009.”; and

13 (2) in subsection (c), by striking “3 percent”
 14 and inserting “3.5 percent”.

15 **SEC. 204. RESERVATIONS AND ALLOTMENTS.**

16 Section 221(b)(3) of the Library Services and Tech-
 17 nology Act (20 U.S.C. 9131(b)(3)) is amended to read as
 18 follows:

19 “(3) MINIMUM ALLOTMENTS.—

20 “(A) IN GENERAL.—For purposes of this
 21 subsection, the minimum allotment for each
 22 State shall be \$340,000, except that the min-
 23 imum allotment shall be \$40,000 in the case of
 24 the United States Virgin Islands, Guam, Amer-
 25 ican Samoa, the Commonwealth of the North-

ern Mariana Islands, the Republic of the Marshall Islands, the Federated States of Micronesia, and the Republic of Palau.

“(B) RATABLE REDUCTIONS.—Notwithstanding subparagraph (A), if the sum appropriated under the authority of section 214 and not reserved under subsection (a) for any fiscal year is insufficient to fully satisfy the requirement of subparagraph (A), each of the minimum allotments under such subparagraph shall be reduced ratably.

“(C) EXCEPTION.—

“(i) IN GENERAL.—Notwithstanding subparagraph (A), if the sum appropriated under the authority of section 214 and not reserved under subsection (a) for any fiscal year exceeds the aggregate of the allotments for all States under this subsection for fiscal year 2003—

“(I) the minimum allotment for each State otherwise receiving a minimum allotment of \$340,000 under subparagraph (A) shall be increased to \$680,000; and

1 “(II) the minimum allotment for
 2 each State otherwise receiving a min-
 3 imum allotment of \$40,000 under
 4 subparagraph (A) shall be increased
 5 to \$60,000.

6 “(ii) INSUFFICIENT FUNDS TO AWARD
 7 ALTERNATIVE MINIMUM.—If the sum ap-
 8 propriated under the authority of section
 9 214 and not reserved under subsection (a)
 10 for any fiscal year exceeds the aggregate of
 11 the allotments for all States under this
 12 subsection for fiscal year 2003 yet is insuf-
 13 ficient to fully satisfy the requirement of
 14 clause (i), such excess amount shall first
 15 be allotted among the States described in
 16 clause (i)(I) so as to increase equally the
 17 minimum allotment for each such State
 18 above \$340,000. After the requirement of
 19 clause (i)(I) is fully satisfied for any fiscal
 20 year, any remainder of such excess amount
 21 shall be allotted among the States de-
 22 scribed in clause (i)(II) so as to increase
 23 equally the minimum allotment for each
 24 such State above \$40,000.

25 “(D) SPECIAL RULE.—

1 “(i) IN GENERAL.—Notwithstanding
2 any other provision of this subsection and
3 using funds allotted for the Republic of the
4 Marshall Islands, the Federated States of
5 Micronesia, and the Republic of Palau
6 under this subsection, the Director shall
7 award grants to the United States Virgin
8 Islands, Guam, American Samoa, the Com-
9 monwealth of the Northern Mariana Is-
10 lands, the Republic of the Marshall Is-
11 lands, the Federated States of Micronesia,
12 or the Republic of Palau to carry out ac-
13 tivities described in this subtitle in accord-
14 ance with the provisions of this subtitle
15 that the Director determines are not incon-
16 sistent with this subparagraph.

17 “(ii) AWARD BASIS.—The Director
18 shall award grants pursuant to clause (i)
19 on a competitive basis and pursuant to rec-
20 ommendations from the Pacific Region
21 Educational Laboratory in Honolulu, Ha-
22 waii.

23 “(iii) ADMINISTRATIVE COSTS.—The
24 Director may provide not more than 5 per-
25 cent of the funds made available for grants

1 under this subparagraph to pay the admin-
 2 istrative costs of the Pacific Region Edu-
 3 cational Laboratory regarding activities as-
 4 sisted under this subparagraph.”.

5 **SEC. 205. STATE PLANS.**

6 Section 224 of the Library Services and Technology
 7 Act (20 U.S.C. 9134) is amended—

8 (1) in subsection (a)(1), by striking “not later
 9 than April 1, 1997.” and inserting “once every 5
 10 years, as determined by the Director.”; and

11 (2) in subsection (f)—

12 (A) by striking “this Act” each place such
 13 term appears and inserting “this subtitle”;

14 (B) in paragraph (1)—

15 (i) by striking “1934,” and all that
 16 follows through “Act, may” and inserting
 17 “1934 (47 U.S.C. 254(h)(6)) may”; and

18 (ii) by striking “section 213(2)(A) or
 19 (B)” and inserting “section 213(1)(A) or
 20 (B)”; and

21 (C) in paragraph (7)—

22 (i) in the matter preceding subpara-
 23 graph (A), by striking “section:” and in-
 24 serting “subsection:”; and

1 (ii) in subparagraph (D), by striking
2 “given” and inserting “applicable to”.

3 **SEC. 206. GRANTS TO STATES.**

4 Section 231 of the Library Services and Technology
5 Act (20 U.S.C. 9141) is amended—

6 (1) in subsection (a), by striking paragraphs
7 (1) and (2) and inserting the following:

8 “(1) expanding services for learning and access
9 to information and educational resources in a variety
10 of formats, in all types of libraries, for individuals
11 of all ages;

12 “(2) developing library services that provide all
13 users access to information through local, State, re-
14 gional, national, and international electronic net-
15 works;

16 “(3) providing electronic and other linkages
17 among and between all types of libraries;

18 “(4) developing public and private partnerships
19 with other agencies and community-based organiza-
20 tions;

21 “(5) targeting library services to individuals of
22 diverse geographic, cultural, and socioeconomic back-
23 grounds, to individuals with disabilities, and to indi-
24 viduals with limited functional literacy or informa-
25 tion skills; and

1 “(6) targeting library and information services
 2 to persons having difficulty using a library and to
 3 underserved urban and rural communities, including
 4 children (from birth through age 17) from families
 5 with incomes below the poverty line (as defined by
 6 the Office of Management and Budget and revised
 7 annually in accordance with section 673(2) of the
 8 Community Services Block Grant Act (42 U.S.C.
 9 9902(2))) applicable to a family of the size in-
 10 volved.”; and

11 (2) in subsection (b), by striking “between the
 12 two purposes described in paragraphs (1) and (2) of
 13 such subsection,” and inserting “among such pur-
 14 poses,”.

15 **SEC. 207. NATIONAL LEADERSHIP GRANTS, CONTRACTS, OR**
 16 **COOPERATIVE AGREEMENTS.**

17 Section 262(a)(1) of the Library Services and Tech-
 18 nology Act (20 U.S.C. 9162(a)(1)) is amended by striking
 19 “education and training” and inserting “education, re-
 20 cruitment, and training”.

21 **TITLE III—MUSEUM SERVICES**

22 **SEC. 300. SHORT TITLE.**

23 Subtitle C of the Museum and Library Services Act
 24 (20 U.S.C. 9171 et seq.) is amended by inserting before
 25 section 271 the following:

1 **“SEC. 270. SHORT TITLE.**

2 “This subtitle may be cited as the ‘Museum Services
3 Act’.”.

4 **SEC. 301. PURPOSE.**

5 Section 271 of the Museum and Library Services Act
6 (20 U.S.C. 9171) is amended to read as follows:

7 **“SEC. 271. PURPOSE.**

8 “It is the purpose of this subtitle—

9 “(1) to encourage and support museums in car-
10 rying out their public service role of connecting the
11 whole of society to the cultural, artistic, historical,
12 natural, and scientific understandings that con-
13 stitute our heritage;

14 “(2) to encourage and support museums in car-
15 rying out their educational role, as core providers of
16 learning and in conjunction with schools, families,
17 and communities;

18 “(3) to encourage leadership, innovation, and
19 applications of the most current technologies and
20 practices to enhance museum services;

21 “(4) to assist, encourage, and support museums
22 in carrying out their stewardship responsibilities to
23 achieve the highest standards in conservation and
24 care of the cultural, historic, natural, and scientific
25 heritage of the United States to benefit future gen-
26 erations;

1 “(5) to assist, encourage, and support museums
 2 in achieving the highest standards of management
 3 and service to the public, and to ease the financial
 4 burden borne by museums as a result of their in-
 5 creasing use by the public; and

6 “(6) to support resource sharing and partner-
 7 ships among museums, libraries, schools, and other
 8 community organizations.”.

9 **SEC. 302. DEFINITIONS.**

10 Section 272(1) of the Museum and Library Services
 11 Act (20 U.S.C. 9172(1)) is amended by adding at the end
 12 the following: “Such term includes aquariums, arbore-
 13 tums, botanical gardens, art museums, children’s muse-
 14 ums, general museums, historic houses and sites, history
 15 museums, nature centers, natural history and anthro-
 16 pology museums, planetariums, science and technology
 17 centers, specialized museums, and zoological parks.”.

18 **SEC. 303. MUSEUM SERVICES ACTIVITIES.**

19 Section 273 of the Museum and Library Services Act
 20 (20 U.S.C. 9173) is amended to read as follows:

21 **“SEC. 273. MUSEUM SERVICES ACTIVITIES.**

22 “(a) IN GENERAL.—The Director, subject to the pol-
 23 icy advice of the Museum and Library Services Board,
 24 may enter into arrangements, including grants, contracts,
 25 cooperative agreements, and other forms of assistance to

1 museums and other entities as the Director considers ap-
2 propriate, to pay for the Federal share of the cost—

3 “(1) to support museums in providing learning
4 and access to collections, information, and edu-
5 cational resources in a variety of formats (including
6 exhibitions, programs, publications, and websites)
7 for individuals of all ages;

8 “(2) to support museums in building learning
9 partnerships with the Nation’s schools and devel-
10 oping museum resources and programs in support of
11 State and local school curricula;

12 “(3) to support museums in assessing, con-
13 serving, researching, maintaining, and exhibiting
14 their collections, and in providing educational pro-
15 grams to the public through the use of their collec-
16 tions;

17 “(4) to stimulate greater collaboration among
18 museums, libraries, schools, and other community
19 organizations in order to share resources and
20 strengthen communities;

21 “(5) to encourage the use of new technologies
22 and broadcast media to enhance access to museum
23 collections, programs, and services;

24 “(6) to support museums in providing services
25 to people of diverse geographic, cultural, and socio-

1 economic backgrounds and to individuals with dis-
2 abilities;

3 “(7) to support museums in developing and car-
4 rying out specialized programs for specific segments
5 of the public, such as programs for urban neighbor-
6 hoods, rural areas, Indian reservations, and State
7 institutions;

8 “(8) to support professional development and
9 technical assistance programs to enhance museum
10 operations at all levels, in order to ensure the high-
11 est standards in all aspects of museum operations;

12 “(9) to support museums in research, program
13 evaluation, and the collection and dissemination of
14 information to museum professionals and the public;
15 and

16 “(10) to encourage, support, and disseminate
17 model programs of museum and library collabora-
18 tion.

19 “(b) FEDERAL SHARE.—

20 “(1) 50 PERCENT.—Except as provided in para-
21 graph (2), the Federal share described in subsection
22 (a) shall be not more than 50 percent.

23 “(2) GREATER THAN 50 PERCENT.—The Direc-
24 tor may use not more than 20 percent of the funds
25 made available under this subtitle for a fiscal year

1 to enter into arrangements under subsection (a) for
 2 which the Federal share may be greater than 50
 3 percent.

4 “(3) OPERATIONAL EXPENSES.—No funds for
 5 operational expenses may be provided under this sec-
 6 tion to any entity that is not a museum.

7 “(c) REVIEW AND EVALUATION.—The Director shall
 8 establish procedures for reviewing and evaluating arrange-
 9 ments described in subsection (a) entered into under this
 10 subtitle. Procedures for reviewing such arrangements shall
 11 not be subject to any review outside of the Institute.

12 “(d) SERVICES FOR NATIVE AMERICANS.—From
 13 amounts appropriated under section 274, the Director
 14 shall reserve 1.75 percent to award grants to, or enter into
 15 contracts or cooperative agreements with, Indian tribes
 16 and to organizations that primarily serve and represent
 17 Native Hawaiians (as defined in section 7207 of the Na-
 18 tive Hawaiian Education Act (20 U.S.C. 7517)) to enable
 19 such tribes and organizations to carry out the activities
 20 described in subsection (a).”.

21 **SEC. 304. REPEALS.**

22 Sections 274 and 275 of the Museum and Library
 23 Services Act (20 U.S.C. 9174 and 9175) are repealed.

1 **SEC. 305. AUTHORIZATION OF APPROPRIATIONS.**

2 Section 276 of the Museum and Library Services Act
3 (20 U.S.C. 9176)—

4 (1) is redesignated as section 274 of such Act;
5 and

6 (2) is amended, in subsection (a), by striking
7 “\$28,700,000 for the fiscal year 1997, and such
8 sums as may be necessary for each of the fiscal
9 years 1998 through 2002.” and inserting
10 “\$65,000,000 for fiscal year 2004 and such sums as
11 may be necessary for fiscal years 2005 through
12 2009.”.

13 **TITLE IV—NATIONAL COMMIS-**
14 **SION ON LIBRARIES AND IN-**
15 **FORMATION SCIENCE ACT**

16 **SEC. 401. AMENDMENT TO CONTRIBUTIONS.**

17 Section 4 of the National Commission on Libraries
18 and Information Science Act (20 U.S.C. 1503) is amended
19 by striking “accept, hold, administer, and utilize gifts, be-
20 quests, and devises of property,” and inserting “solicit, ac-
21 cept, hold, administer, invest in the name of the United
22 States, and utilize gifts, bequests, and devises of services
23 or property,”.

1 **SEC. 402. AMENDMENT TO MEMBERSHIP.**

2 Section 6(a) of the National Commission on Libraries
3 and Information Science Act (20 U.S.C. 1505(a)) is
4 amended—

5 (1) in the second sentence, by striking “and at
6 least one other of whom shall be knowledgeable with
7 respect to the library and information service and
8 science needs of the elderly”;

9 (2) by amending the fourth sentence to read as
10 follows: “A majority of members of the Commission
11 who have taken office and are serving on the Com-
12 mission shall constitute a quorum for conduct of
13 business at official meetings of the Commission”;
14 and

15 (3) in the fifth sentence, by striking “five years,
16 except that” and all that follows through the period
17 and inserting “five years, except that—

18 “(1) a member of the Commission appointed to
19 fill a vacancy occurring prior to the expiration of the
20 term for which the member’s predecessor was ap-
21 pointed, shall be appointed only for the remainder of
22 such term; and

23 “(2) any member of the Commission may con-
24 tinue to serve after an expiration of the member’s
25 term of office until such member’s successor is ap-

pointed, has taken office, and is serving on the Commission.”.

TITLE V—MISCELLANEOUS PROVISIONS

SEC. 501. AMENDMENTS TO ARTS AND ARTIFACTS INDEMNITY ACT.

Section 5 of the Arts and Artifacts Indemnity Act (20 U.S.C. 974) is amended—

(1) in subsection (b), by striking “\$5,000,000,000” and inserting “\$8,000,000,000”;

(2) in subsection (c), by striking “\$500,000,000” and inserting “\$750,000,000”; and

(3) in subsection (d)—

(A) in paragraph (6), by striking “or” after the semicolon;

(B) by striking paragraph (7) and inserting the following:

“(7) not less than \$400,000,000 but less than \$500,000,000, then coverage under this chapter shall extend only to loss or damage in excess of the first \$400,000 of loss or damage to items covered; or

“(8) \$500,000,000 or more, then coverage under this chapter shall extend only to loss or dam-

1 age in excess of the first \$500,000 of loss or damage
2 to items covered.”.

3 **SEC. 502. NATIONAL CHILDREN’S MUSEUM.**

4 (a) DESIGNATION.—The Capital Children’s Museum
5 located at 800 Third Street, NE, Washington, D.C. (or
6 any successor location), organized under the laws of the
7 District of Columbia, is designated as the “National Chil-
8 dren’s Museum”.

9 (b) REFERENCES.—Any reference in a law, map, reg-
10 ulation, document, paper, or other record of the United
11 States to the Capital Children’s Museum referred to in
12 subsection (a) shall be deemed to be a reference to the
13 National Children’s Museum.

14 **SEC. 503. TECHNICAL CORRECTIONS.**

15 (a) TITLE HEADING.—The title heading for the Mu-
16 seum and Library Services Act (20 U.S.C. 9101 et seq.)
17 is amended to read as follows:

18 **“TITLE II—MUSEUM AND**

8 subtitle C of the Museum and Library Services Act (20
9 U.S.C. 9171 et seq.) is amended to read as follows:

10 **“Subtitle C—Museum Services”.**

11 (e) CONTRIBUTIONS.—Section 208 of the Museum
12 and Library Services Act (20 U.S.C. 9106) (as redesign-
13 nated by section 104 of this Act) is amended by striking
14 “property of services” and inserting “property or serv-
15 ices”.

16 (f) STATE PLAN CONTENTS.—Section 224(b)(5) of
17 the Library Services and Technology Act (20 U.S.C.
18 9134(b)(5)) is amended by striking “and” at the end.

19 (g) NATIONAL LEADERSHIP GRANTS, CONTRACTS,
20 OR COOPERATIVE AGREEMENTS.—Section 262(b)(1) of
21 the Library Services and Technology Act (20 U.S.C.
22 9162(b)(1)) is amended by striking “cooperative agree-
23 ments, with,” and inserting “cooperative agreements
24 with,”.

1 **SEC. 504. CONFORMING AMENDMENT.**

2 Section 170(e)(6)(B)(i)(III) of the Internal Revenue
 3 Code of 1986 (relating to the special rule for contributions
 4 of computer technology and equipment for educational
 5 purposes) is amended by striking “section 213(2)(A) of
 6 the Library Services and Technology Act (20 U.S.C.
 7 9122(2)(A))” and inserting “section 213(1)(A) of the Li-
 8 brary Services and Technology Act (20 U.S.C.
 9 9122(1)(A))”.

10 **SEC. 505. REPEALS.**

11 (a) NATIONAL COMMISSION ON LIBRARIES AND IN-
 12 FORMATION SCIENCE ACT.—Section 5 of the National
 13 Commission on Libraries and Information Science Act (20
 14 U.S.C. 1504) is amended by striking subsections (b) and
 15 (c) and redesignating subsections (d), (e), and (f) as sub-
 16 sections (b), (c), and (d), respectively.

17 (b) MUSEUM AND LIBRARY SERVICES ACT OF
 18 1996.—Sections 704 through 707 of the Museum and Li-
 19 brary Services Act of 1996 (20 U.S.C. 9102 note, 9103
 20 note, and 9105 note) are repealed.

21 **SEC. 506. EFFECTIVE DATE.**

22 The amendments made by this Act shall take effect
 23 on October 1, 2003.
