A BILL

To expand the boundaries of Wilson's Creek Battlefield
National Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Wilson's Creek Na-
5 tional Battlefield Boundary Adjustment Act of 2004".

1 **SEC. 2. EXPANSION OF BOUNDARIES, WILSON'S CREEK NA-**
2 **TIONAL BATTLEFIELD, MISSOURI.**

3 (a) BOUNDARY EXPANSION.—The first section of
4 Public Law 86–434 (16 U.S.C. 430kk) is amended—

5 (1) by inserting “(a)” after “That”; and

6 (2) by adding at the end the following:

7 “(b)(1) The boundaries of the Wilson’s Creek Na-
8 tional Battlefield are revised to include land and interests
9 in land consisting of 6 parcels totaling 615 acres and iden-
10 tified as parcels 1 through 6 on the map entitled ‘Wilson’s
11 Creek National Battlefield Proposed Boundary’, numbered
12 410/80,037 and dated January 27, 2004.

13 “(2) The map referred to in paragraph (1) shall be
14 maintained on file and available for public inspection in
15 the appropriate offices of the National Park Service.

16 “(3) The Secretary of the Interior may acquire by
17 donation, purchase from willing sellers with donated or ap-
18 propriated funds, or exchange—

19 “(A) land and interests in land referred to in
20 paragraph (1); and

21 “(B) personal property associated with, and ap-
22 propriate for, interpretation of the park designated
23 under section 2.”.

24 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
25 3 of Public Law 86–434 (16 U.S.C. 430mm) is amend-
26 ed—

1 (1) by inserting “(a)” after “SEC. 3”; and

2 (2) by adding at the end the following:

3 “(b) There are authorized to be appropriated such
4 sums as are necessary to carry out subsection (b) of the
5 first section.”.

Amend the title so as to read: “A bill to expand the boundaries of Wilson’s Creek National Battlefield, and for other purposes.”.
