AN ACT

To reauthorize the Congressional Award Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REAUTHORIZATION OF THE CONGRESSIONAL**
 2 **AWARD ACT.**

3 (a) EXTENSION OF REQUIREMENTS REGARDING FI-
 4 NANCIAL OPERATIONS OF CONGRESSIONAL AWARD PRO-
 5 GRAM; NONCOMPLIANCE WITH REQUIREMENTS.—Section
 6 104(c)(2)(A) of the Congressional Award Act (2 U.S.C.
 7 804(c)(2)(A)) is amended by striking “and 2004” and in-
 8 serting “2004, 2005, 2006, 2007, 2008, and 2009”.

9 (b) TERMINATION.—Section 108 of the Congres-
 10 sional Award Act (2 U.S.C. 808) is amended by striking
 11 “October 1, 2004” and inserting “October 1, 2009”.

12 (c) TECHNICAL AMENDMENTS.—The Congressional
 13 Award Act is amended—

14 (1) in section 103(b)(3)(B) (2 U.S.C.
 15 803(b)(3)(B)), by striking “section” each place it
 16 appears and inserting “subsection”; and

17 (2) in section 104(c)(2)(A) (2 U.S.C.
 18 804(c)(2)(A)), by inserting a comma after “1993”.

19 **SEC. 2. FEDERAL FUNDS AND RESOURCES.**

20 (a) TECHNICAL AMENDMENTS; CLARIFICATION OF
 21 ACCEPTANCE OF FEDERAL FUNDS AND RESOURCES.—
 22 Section 106 of the Congressional Award Act (2 U.S.C.
 23 806) is amended—

24 (1) in subsection (a)(1), by striking “from
 25 sources other than the Federal Government”;

1 (2) in the heading of subsection (e), by striking
 2 “NON-FEDERAL FUNDS AND RESOURCES; INDIRECT
 3 RESOURCES” and inserting “FUNDS AND RE-
 4 SOURCES”;

5 (3) in subsection (e)—

6 (A) in paragraph (1), by striking “Subject
 7 to the provisions of paragraph (2), the” and in-
 8 serting “The”; and

9 (B) by striking paragraph (2) and insert-
 10 ing the following:

11 “(2) The Board—

12 “(A) may benefit from in-kind and indirect re-
 13 sources provided by Offices of Members of Congress;

14 “(B) is not prohibited from receiving benefits
 15 from efforts or activities undertaken in collaboration
 16 with entities which receive Federal funds or re-
 17 sources; and

18 “(C) may not accept more than one-half of all
 19 funds accepted from Federal sources.”; and

20 (4) adding at the end the following:

21 “(j) AUTHORIZATION OF APPROPRIATIONS.—There
 22 are authorized to be appropriated to the Board to carry

1 out this Act \$750,000 for each of fiscal years 2005, 2006,
2 2007, 2008, and 2009.”.
