A BILL

To amend title XVIII of the Social Security Act to recognize the services of respiratory therapists under the plan of care for home health services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. MEDICARE RECOGNITION OF SERVICES OF
- 4 RESPIRATORY THERAPISTS UNDER A PLAN
- 5 OF CARE FOR HOME HEALTH SERVICES.
- 6 (a) IN GENERAL.—Section 1861(m) of the Social Se-
- 7 curity Act (42 U.S.C. 1395x(m)) is amended by adding
- 8 at the end the following: "For purposes of paragraphs (1)
- 9 and (2), when respiratory therapy services are furnished
- 10 as part-time or intermittent nursing care or physical ther-

- 1 apy services under a home health plan of care, a res-
- 2 piratory therapist, acting within the therapist's scope of
- 3 practice, may furnish such services.".
- 4 (b) No Impact on Payment.—The provision of res-
- 5 piratory therapy services as part of home health services
- 6 under the amendment made by subsection (a) shall not
- 7 affect the Low Utilization Payment Adjustment (LUPA),
- 8 the outlier adjustment, or the therapy threshold under the
- 9 system of prospective payment for home health agencies
- 10 under section 1895 of the Social Security Act.
- 11 (c) Effective Date.—The amendment made by
- 12 subsection (a) shall apply to services furnished on or after
- 13 January 1, 2004.
- 14 SEC. 2. REPORT ON MEDICARE COVERAGE OF RES-
- 15 PIRATORY THERAPY SERVICES.
- 16 (a) Study.—The Secretary of Health and Human
- 17 Services shall conduct a study on the impact of paying
- 18 for the services of respiratory therapists as a separate ben-
- 19 efit under part B of title XVIII of the Social Security Act
- 20 and as an explicit component of the several benefits under
- 21 part A of such title. The Secretary shall include in such
- 22 study data on the utilization of respiratory therapists
- 23 under the amendment made by section 1(a).
- 24 (b) Report.—Not later than 2 years after the date
- 25 of the enactment of this Act, the Secretary shall submit

- 1 to Congress a report of the findings of the study conducted
- 2 under subsection (a).
