A BILL

To develop the National Strategy for Homeland Security, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Strategy for
- 5 Homeland Security Act of 2004".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act, the following definitions shall apply:
- 8 (1) Commission.—The term "Commission"
- 9 means the Homeland Security Strategy Commission
- 10 established under section 4.

| 6 | SEC. 3. NATIONAL STRATEGY FOR HOMELAND SECURITY. |
| 7 | (a) Development and Submission of Strat- |
| 8 | EGY.— |
| 9 | (1) Development.—The Secretary, under the |
| 10 | direction of the President, and in collaboration with |
| 11 | the Assistant to the President for Homeland Secu- |
| 12 | rity and the Homeland Security Council, shall de- |
| 13 | velop the National Strategy for Homeland Security |
| 14 | for the detection, prevention, protection, response, |
| 15 | and recovery with regard to terrorist threats to the |
| 16 | United States. |
| 17 | (2) Submission to congress.— |
| 18 | (A) Initial submission.—Not later than |
| 19 | December 1, 2005, and not later than Decem- |
| 20 | ber 1st of each year in which a President is in- |
| 21 | augurated, the Secretary shall submit the Strat- |
| 22 | egy to Congress. |
| 23 | (B) BIENNIAL UPDATE.—Not later than 2 |
| 24 | years after each submission of the Strategy |
| 25 | under subparagraph (A), the Secretary shall |

- submit to Congress an updated version of the
 Strategy.
- (C) PROGRESS REPORTS.—Each year, in conjunction with the President's budget request, the Secretary shall provide an assessment of progress on implementing the Strategy, including the adequacy of resources to meet the objectives of the Strategy, and recommendations to improve and implement the Strategy.
- 10 (3) CLASSIFIED MATERIAL.—Any part of the 11 Strategy that involves information that is properly 12 classified under criteria established by Executive 13 Order shall be submitted to Congress separately in 14 classified form.
- 15 (b) COORDINATION WITH THE ASSISTANT TO THE
 16 PRESIDENT FOR HOMELAND SECURITY.—The Secretary
 17 shall seek the assistance of the Assistant to the President
 18 for Homeland Security and the Homeland Security Coun19 cil to—
- 20 (1) coordinate the input of Federal departments 21 and agencies outside the Department of Homeland 22 Security, which have homeland security responsibil-23 ities; and
- (2) work with the Secretary on all aspects ofthe Strategy.

| 14 | (2) Additional contents.—In addition to |
| 15 | the items listed in paragraph (1), the Strategy shall |
| 16 | include— |
| 17 | (A) policies and procedures to maximize |
| 18 | the collection, translation, analysis, exploitation, |
| 19 | and dissemination of information relating to |
| 20 | combating terrorism and the homeland security |
| 21 | response throughout the Federal government, |
| 22 | and with State and local authorities, and, as |
| 23 | appropriate, the private sector; |

| 1 | (B) plans for countering chemical, biologi- |

| 4 | (C) plans for the coordination with, and in- |

| 12 | (d) COOPERATION.—At the request of the Secretary |
| 13 | or the Assistant to the President for Homeland Security, |
| 14 | Federal agencies shall provide necessary information or |
| 15 | planning documents relating to the Strategy. |
| 16 | SEC. 4. NATIONAL HOMELAND SECURITY COMMISSION. |
| 17 | (a) Establishment.—The Secretary shall establish |
| 18 | a nonpartisan, independent commission to be known as |
| 19 | the Homeland Security Commission. |
| 20 | (b) Membership.— |
| 21 | (1) Composition.—The Commission shall be |
| 22 | composed of 9 members, including a chair, who shall |
| 23 | be appointed by the Secretary, in consultation with |
| 24 | the chairman and ranking member of— |

| 1 | (A) the Committee on Governmental Af- |

| 3 | (B) the Select Committee on Homeland |
| 4 | Security of the House of Representatives. |
| 5 | (2) Qualifications.—Members of the Com- |
| 6 | mission appointed under paragraph (1)— |
| 7 | (A) shall be recognized experts in matters |
| 8 | relating to the homeland security of the United |
| 9 | States; and |
| 10 | (B) shall not be officers or employees of |
| 11 | the Federal Government. |
| 12 | (3) Period of Appointment.—Each member |
| 13 | of the Commission shall be appointed to the Com- |
| 14 | mission for an 18-month term, which shall begin on |
| 15 | December 1, 2005. |
| 16 | (4) Vacancies.—Any vacancy in the Commis- |
| 17 | sion shall not affect its powers, but shall be filled in |
| 18 | the same manner as the original appointment. |
| 19 | (5) Quorum.—A majority of the members of |
| 20 | the Commission shall constitute a quorum, but a |
| 21 | lesser number of members may hold hearings. A |
| 22 | quorum is required to approve any report issued by |
| 23 | the Commission, but a minority of members may |
| 24 | submit an appendix to be included in such report. |

- 1 (c) Duties.—The Commission shall conduct an inde-
- 2 pendent, alternative assessment of the optimal policies and
- 3 programs to improve homeland security against terrorist
- 4 threats, including, to the extent practicable, an estimate
- 5 of the funding required each fiscal year to support such
- 6 policies and programs.
- 7 (d) Compensation.—Each member of the Commis-
- 8 sion shall be compensated at a rate equal to the daily
- 9 equivalent of the annual rate of basic pay prescribed for
- 10 level IV of the Executive Schedule under section 5315 of
- 11 title 5, United States Code, for each day, including travel
- 12 time, during which the member is engaged in the perform-
- 13 ance of the duties of the Commission.
- 14 (e) Travel Expenses.—Each member of the Com-
- 15 mission shall be allowed travel expenses, including per
- 16 diem in lieu of subsistence, at rates authorized for employ-
- 17 ees of agencies under subchapter I of chapter 57 of title
- 18 5, United States Code, while away from their homes or
- 19 regular places of business in the performance of services
- 20 for the Commission.
- 21 (f) Staff.—
- 22 (1) In General.—The Chair of the Commis-
- sion may, without regard to the civil service laws
- and regulations, appoint and terminate an executive
- 25 director (subject to Commission confirmation) and

such other additional personnel as may be necessary to enable the Commission to perform its duties.

(2) Compensation.—The Chair of the Commission may fix the compensation of the executive director and other personnel without regard to chapter 51 and subchapter III of chapter 53 of title 5, United States Code, relating to the classification of positions and General Schedule pay rates, except that the rate of pay may not exceed the rate payable for level V of the Executive Schedule under section 5316 of such title.

(3) Personnel as federal employees.—

- (A) IN GENERAL.—The executive director and all employees of the Commission shall be employees under section 2015 of title 5, United States Code, for purposes of chapters 63, 81, 83, 84, 85, 87, 89, and 90 of such title.
- (B) Members of commission.—Subparagraph (A) shall not apply to members of the Commission.
- (4) Detail of government employees.—
 Any Federal Government employee may be detailed to the Commission without reimbursement, and such detail shall be without interruption or loss of civil service status or privilege.

| 2 | (1) USE OF MAIL AND PRINTING.—The Com- |
| 3 | mission may use the United States mails and obtain |
| 4 | printing and binding services in the same manner |
| 5 | and under the same conditions as other departments |
| 6 | and agencies of the Federal Government. |
| 7 | (2) Support Services.—The Secretary shall |
| 8 | furnish the Commission any administrative and sup- |
| 9 | port services requested by the Commission. |
| 10 | (3) Gifts.—The Commission may accept and |
| 11 | dispose of gifts or donations of services or property. |
| 12 | (h) Payment of Commission Expenses.—The |
| 13 | compensation, travel expenses, and per diem allowances |
| 14 | of members and employees of the Commission shall be |
| 15 | paid out of funds available to the Department for the pay- |
| 16 | ment of compensation, travel allowances and per diem al- |
| 17 | lowances, respectively, of civilian employees of the Depart- |
| 18 | ment. The other expenses of the Commission shall be paid |
| 19 | out of funds available to the Department for the payment |
| 20 | of similar expenses incurred by the Department. |
| 21 | (i) Report.—Not later than December 1, 2006, the |
| 22 | Commission shall submit, to the committees referred to |
| 23 | under subsection (b)(1), a report that— |
| 24 | (1) describes the activities, findings, and rec- |
| 25 | ommendations of the Commission; and |

- 1 (2) provides recommendations for legislation
- 2 that the Commission considers appropriate.
