A BILL

To amend the Education Sciences Reform Act of 2002 to require the Statistics Commissioner to collect information from coeducational secondary schools on such schools' athletic programs.

1 *Be it enacted by the Senate and House of Representa-*

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "High School Sports

5 Information Collection Act of 2003".

1 **SEC. 2. STATISTICS ON EQUALITY IN ATHLETIC PROGRAMS.**

2 Section 153 of the Education Sciences Reform Act
3 of 2002 (20 U.S.C. 9543) is amended by adding at the
4 end the following:

5 “(c) EQUALITY IN ATHLETIC PROGRAMS.—The Sta-
6 tistics Commissioner shall collect, annually, for the imme-
7 diately preceding academic year, from each coeducational
8 secondary school (as defined in section 9101 of the Ele-
9 mentary and Secondary Education Act of 1965 (20 U.S.C.
10 7801)) that receives Federal financial assistance that has
11 an athletic program, the following information:

12 “(1) The number of male and female students
13 that attended the school.

14 “(2) A listing of the teams that competed in
15 athletic competition and for each such team the fol-
16 lowing data:

17 “(A) The season in which the team com-
18 peted.

19 “(B) The total number of participants as
20 of the day of the first scheduled contest for the
21 team, and for each participant an identification
22 of such participant’s—

23 “(i) gender;

24 “(ii) race; and

25 “(iii) ethnicity.

1 “(C) The total budget and expenditures for
2 the team, including the following data:

3 “(i) The travel budget and expendi-
4 tures.

5 “(ii) The equipment budget and ex-
6 penditures (including any equipment re-
7 placement schedule).

8 “(iii) The uniform budget and expendi-
9 tures (including any uniform replacement
10 schedule).

11 “(iv) The budget and expenditures for
12 facilities, including locker rooms, fields,
13 and gymnasiums.

14 “(v) The total number of trainers (in-
15 cluding full-time and part-time) and for
16 each trainer an identification of such train-
17 er’s gender.

18 “(vi) The budget and expenditures for
19 publicity for competitions.

20 “(D) The total number of coaches (includ-
21 ing full-time, part-time, head, and assistant)
22 and for each coach an identification of such
23 coach’s—

24 “(i) gender; and

25 “(ii) qualifications.

1 “(E) The total number of competitions
2 scheduled, and for each scheduled competition
3 an indication of what time the competition was
4 scheduled.

5 “(F) Whether such team participated in
6 postseason competition, and the success of such
7 team in any postseason competition.”.
