Mr. Feingold (for himself and Ms. Collins) introduced the following bill; which was read twice and referred to the Committee on Governmental Affairs

A BILL

To make changes to the Office for State and Local Government Coordination, Department of Homeland Security.

1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, 3 SECTION 1. OFFICE FOR STATE AND LOCAL GOVERNMENT 4 COORDINATION. 5 Section 801 of the Homeland Security Act of 2002 is amended— (1) in subsection (a), by striking "to oversee" 7 8 and inserting "to be headed by a director, which shall oversee"; 9

(2) in subsection (b)—

1	(A) in paragraph (3), by striking "and"
2	after the semicolon;
3	(B) in paragraph (4), by striking the pe-
4	riod at the end and inserting "; and"; and
5	(C) by adding at the end the following:
6	"(5) prepare an annual report, that contains—
7	"(A) a description of the State and local
8	priorities in each of the 50 States based on dis-
9	covered needs of first responder organizations,
10	including law enforcement agencies, fire and
11	rescue agencies, medical providers, emergency
12	service providers, and relief agencies;
13	"(B) a needs assessment that identifies
14	homeland security functions in which the Fed-
15	eral role is duplicative of the State or local role,
16	and recommendations to decrease or eliminate
17	inefficiencies between the Federal Government
18	and State and local entities;
19	"(C) recommendations to Congress regard-
20	ing the creation, expansion, or elimination of
21	any program to assist State and local entities to
22	carry out their respective functions under the
23	Department; and

1	"(D) proposals to increase the coordination
2	of Department priorities within each State and
3	between the States."; and
4	(3) by adding at the end the following:
5	"(c) Homeland Security Liaison Officers.—
6	"(1) Designation.—The Secretary shall des-
7	ignate in each State and the District of Columbia
8	not less than 1 employee of the Department to serve
9	as the Homeland Security Liaison Officer in that
10	State or District.
11	"(2) Duties.—Each Homeland Security Liai-
12	son Officer designated under paragraph (1) shall—
13	"(A) provide State and local government
14	officials with regular information, research, and
15	technical support to assist local efforts at secur-
16	ing the homeland;
17	"(B) provide coordination between the De-
18	partment and State and local first responders,
19	including—
20	"(i) law enforcement agencies;
21	"(ii) fire and rescue agencies;
22	"(iii) medical providers;
23	"(iv) emergency service providers; and
24	"(v) relief agencies;

1	"(C) notify the Department of the State
2	and local areas requiring additional informa-
3	tion, training, resources, and security;
4	"(D) provide training, information, and
5	education regarding homeland security for
6	State and local entities;
7	"(E) identify homeland security functions
8	in which the Federal role is duplicative of the
9	State or local role, and recommend ways to de-
10	crease or eliminate inefficiencies;
11	"(F) assist State and local entities in pri-
12	ority setting based on discovered needs of first
13	responder organizations, including law enforce-
14	ment agencies, fire and rescue agencies, medical
15	providers, emergency service providers, and re-
16	lief agencies;
17	"(G) assist the Department to identify and
18	implement State and local homeland security
19	objectives in an efficient and productive man-
20	ner;
21	"(H) serve as a liaison to the Department
22	in representing State and local priorities and
23	concerns regarding homeland security;

1	"(I) consult with State and local govern-
2	ment officials, including emergency managers,
3	to coordinate efforts and avoid duplication; and
4	"(J) coordinate with Homeland Security
5	Liaison Officers in neighboring States to—
6	"(i) address shared vulnerabilities;
7	and
8	"(ii) identify opportunities to achieve
9	efficiencies through interstate activities.
10	"(d) Federal Interagency Committee on First
11	RESPONDERS AND STATE, LOCAL, AND CROSS-JURISDIC-
12	TIONAL ISSUES.—
13	"(1) IN GENERAL.—There is established an
14	Interagency Committee on First Responders and
15	State, Local, and Cross-jurisdictional Issues (in this
16	section referred to as the "Interagency Committee"),
17	that shall—
18	"(A) ensure coordination, with respect to
19	homeland security functions, among the Federal
20	agencies involved with—
21	"(i) State, local, and regional govern-
22	ments;
23	"(ii) State, local, and community-
24	based law enforcement;
25	"(iii) fire and rescue operations; and

1	"(iv) medical and emergency relief
2	services;
3	"(B) identify community-based law en-
4	forcement, fire and rescue, and medical and
5	emergency relief services needs;
6	"(C) recommend new or expanded grant
7	programs to improve community-based law en-
8	forcement, fire and rescue, and medical and
9	emergency relief services;
10	"(D) identify ways to streamline the proc-
11	ess through which Federal agencies support
12	community-based law enforcement, fire and res-
13	cue, and medical and emergency relief services;
14	and
15	"(E) assist in priority setting based on dis-
16	covered needs.
17	"(2) Membership.—The Interagency Com-
18	mittee shall be composed of—
19	"(A) a representative of the Office for
20	State and Local Government Coordination;
21	"(B) a representative of the Health Re-
22	sources and Services Administration of the De-
23	partment of Health and Human Services:

1	"(C) a representative of the Centers for
2	Disease Control and Prevention of the Depart-
3	ment of Health and Human Services;
4	"(D) a representative of the Federal Emer-
5	gency Management Agency of the Department;
6	"(E) a representative of the United States
7	Coast Guard of the Department;
8	"(F) a representative of the Department of
9	Defense;
10	"(G) a representative of the Office of Do-
11	mestic Preparedness of the Department;
12	"(H) a representative of the Directorate of
13	Immigration Affairs of the Department;
14	"(I) a representative of the Transportation
15	Security Agency of the Department;
16	"(J) a representative of the Federal Bu-
17	reau of Investigation of the Department of Jus-
18	tice; and
19	"(K) representatives of any other Federal
20	agency identified by the President as having a
21	significant role in the purposes of the Inter-
22	agency Committee.
23	"(3) Administration.—The Department shall
24	provide administrative support to the Interagency

1	Committee and the Advisory Council, which shall in-
2	clude—
3	"(A) scheduling meetings;
4	"(B) preparing agenda;
5	"(C) maintaining minutes and records;
6	"(D) producing reports; and
7	"(E) reimbursing Advisory Council mem-
8	bers.
9	"(4) Leadership.—The members of the Inter-
10	agency Committee shall select annually a chair-
11	person.
12	"(5) Meetings.—The Interagency Committee
13	shall meet—
14	"(A) at the call of the Secretary; or
15	"(B) not less frequently than once every 3
16	months.
17	"(e) Advisory Council for the Interagency
18	COMMITTEE.—
19	"(1) Establishment.—There is established an
20	Advisory Council for the Interagency Committee (in
21	this section referred to as the "Advisory Council").
22	"(2) Membership.—
23	"(A) In General.—The Advisory Council
24	shall be composed of not more than 13 mem-
25	bers, selected by the Interagency Committee.

1	"(B) Duties.—The Advisory Council
2	shall—
3	"(i) develop a plan to disseminate in-
4	formation on first response best practices;
5	"(ii) identify and educate the Sec-
6	retary on the latest technological advances
7	in the field of first response;
8	"(iii) identify probable emerging
9	threats to first responders;
10	"(iv) identify needed improvements to
11	first response techniques and training;
12	"(v) identify efficient means of com-
13	munication and coordination between first
14	responders and Federal, State, and local
15	officials;
16	"(vi) identify areas in which the De-
17	partment can assist first responders; and
18	"(vii) evaluate the adequacy and time-
19	liness of resources being made available to
20	local first responders.
21	"(C) Representation.—The Interagency
22	Committee shall ensure that the membership of
23	the Advisory Council represents—
24	"(i) the law enforcement community;
25	"(ii) fire and rescue organizations;

1	"(iii) medical and emergency relief
2	services; and
3	"(iv) both urban and rural commu-
4	nities.
5	"(3) Chairperson.—The Advisory Council
6	shall select annually a chairperson from among its
7	members.
8	"(4) Compensation of members.—The mem-
9	bers of the Advisory Council shall serve without
10	compensation, but shall be eligible for reimburse-
11	ment of necessary expenses connected with their
12	service to the Advisory Council.
13	"(5) Meetings.—The Advisory Council shall
14	meet with the Interagency Committee not less fre-
15	quently than once every 3 months "
