1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “PILT and Revenue
5 Refuge Sharing Permanent Funding Act”.

1 **SEC. 2. DISTRIBUTION OF PAYMENTS.**

2 Section 6903(c)(2) of title 31, United States Code,
3 is amended to read as follows:

4 “The limitation for a unit of general local government
5 with a population of at least 5,000 is the following amount
6 (rounding the population off to the nearest thousand):

**1 SEC. 3. PERMANENT FUNDING FOR PILT AND REFUGE REV-
2 ENUE SHARING.**

3 (a) PAYMENTS IN LIEU OF TAXES.—Section 6906 of
4 title 31, United States Code, is amended to read as fol-
5 lows:

6 “Beginning in fiscal year 2003 and each year there-
7 after, amounts authorized under this chapter shall be
8 made available to the Secretary of the Interior, without
9 further appropriation, for obligation or expenditure in ac-
10 cordance with this chapter.”.

11 (b) REFUGE REVENUE SHARING.—Section 401(d) of
12 the Act of June 15, 1935, as amended (16 U.S.C.
13 715s(d)) (related to refuge revenue sharing) is amended
14 by adding at the end thereof:

15 “Beginning in fiscal year 2003 and each year thereafter,
16 such amount shall be made available to the Secretary,
17 without further appropriation, for obligation or expendi-
18 ture in accordance with this section.”.—

19 SEC. 4. AUTHORIZATION OF APPROPRIATIONS.

20 There is authorized to be appropriated such sums as
21 may be necessary to carry out this Act.

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “PILT and Refuge Rev-*
 3 *enue Sharing Permanent Funding Act”.*

4 **SEC. 2. PERMANENT FUNDING.**

5 (a) *PAYMENTS IN LIEU OF TAXES.*—

6 (1) *IN GENERAL.*—Section 6906 of title 31,
 7 *United States Code, is amended to read as follows:*

8 **“§ 6906. Funding**

9 *“For fiscal year 2005 and each fiscal year thereafter,*
 10 *amounts authorized under this chapter shall be made avail-*
 11 *able to the Secretary of the Interior, without further appro-*
 12 *priation, for obligation or expenditure in accordance with*
 13 *this chapter.”.*

14 (2) *CONFORMING AMENDMENT.*—*The table of sec-*
 15 *tions for chapter 69 of title 31, United States Code,*
 16 *is amended by striking the item relating to section*
 17 *6906 and inserting the following:*

“6906. Funding.”.

18 (b) *REFUGE REVENUE SHARING.*—Section 401(d) of
 19 *the Act of June 15, 1935 (16 U.S.C. 715s(d)) is amended—*

20 (1) *by striking “If the net receipts” and insert-*
 21 *ing the following:*

22 *“(1) If the net receipts”; and*

23 (2) *by adding at the end the following:*

24 *“(2) For fiscal year 2005 and each fiscal year there-*
 25 *after, the amount made available under paragraph (1) shall*

1 *be made available to the Secretary, without further appro-*
2 *priation, for obligation or expenditure in accordance with*
3 *this section.”.*
