7	SEC. 3. REQUIREMENT TO OPPOSE MULTILATERAL ASSIST-
8	ANCE FOR ETHIOPIA.
9	The Secretary of the Treasury shall instruct the
10	United States executive director to each appropriate inter-
11	national financial institution in which the United States
12	participates, to oppose, and vote against the extension by
13	such institution of any loan or financial or technical assist-
14	ance to the Federal Democratic Republic of Ethiopia until
15	such time as the President transmits to Congress a certifi-
16	cation pursuant to section 2(a).
17	SEC. 4. REPORT.
18	The President shall transmit to Congress an annual
19	report on the implementation of this Act. Each such re-
20	port shall include a detailed description of all claims that
21	are outstanding during the preceding year by United
22	States citizens and entities described in section 2(a) for
23	property nationalized, expropriated, or otherwise seized by
