- 4 (a) Maintenance of Program.—The steel import
- 5 licensing and monitoring program established by the Sec-
- 6 retary of the Treasury and the Secretary of Commerce
- 7 pursuant to the Memorandum signed by the President on
- 8 March 5, 2002 (67 Fed. Reg. 10593 through 10597) (pur-
- 9 suant to the authority of the President under section
- 10 203(g) of the Trade Act of 1974), shall, notwithstanding
- 11 any other action taken by the President under section 203
- 12 of the Trade Act of 1974 concerning the steel products
- 13 described in the Memorandum, remain in effect and be
- 14 established by the Secretary of Commerce as a permanent

- in accordance with subsection (a), the Secretary of

14	(D) Subheading 7310.10.00 (relating to
15	barrels and drums).
16	(E) Heading 7312 (relating to strand and

20	(G) Headings 7314, 7315, and 7317.00
21	(relating to fabricated wire).

1	(c) Additional Authority.—The Secretary of the
2	Treasury and the Secretary of Commerce are hereby au-

7	(2) to expand, as necessary and appropriate,
