Mr. BUTTERFIELD introduced the following bill; which was referred to the Committee on Resources

A BILL

To direct the Secretary of the Interior to conduct a study of the suitability and feasibility of establishing the Northeastern North Carolina Heritage Area in North Carolina, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Northeastern North
5 Carolina Heritage Area Study Act of 2005”.

6 **SEC. 2. STUDY.**

7 The Secretary of the Interior, in consultation with
8 appropriate State historic preservation officers, State his-

1 torical societies, and North Carolina’s Northeast Partner-
2 ship, and other appropriate agencies shall conduct a study
3 regarding the suitability and feasibility of designating the
4 study area described in section 3 as the Northeastern
5 North Carolina Heritage Study Area. The study shall in-
6 clude analysis, documentation, and determination regard-
7 ing whether the study area—

8 (1) has an assemblage of natural, historic, and
9 cultural resources that together represent distinctive
10 aspects of American heritage worthy of recognition,
11 conservation, interpretation, and continuing use, and
12 are best managed through partnerships among pub-
13 lic and private entities and by combining diverse and
14 sometime noncontiguous resources and active com-
15 munities;

16 (2) reflects traditions, customs, beliefs, and
17 folklife that are a valuable part of the national story;

18 (3) provides outstanding opportunities to con-
19 serve natural, historic, cultural, or scenic features;

20 (4) provides outstanding recreational and edu-
21 cational opportunities;

22 (5) contains resources important to the identi-
23 fied theme or themes of the study area that retain
24 a degree of integrity capable of supporting interpre-
25 tation;

1 (6) includes residents, business interests, non-
2 profit organizations, and local and State govern-
3 ments that are involved in the planning, have devel-
4 oped a conceptual financial plan that outlines the
5 roles of all participants including the Federal Gov-
6 ernment), and have demonstrated support for the
7 concept of a national heritage area;

8 (7) has a potential management entity to work
9 in partnership with residents, business interests,
10 nonprofit organizations, and local and State govern-
11 ments to develop a national heritage area consistent
12 with continued local and State economic activity;
13 and

14 (8) has a conceptual boundary map that is sup-
15 ported by the public.

16 **SEC. 3. BOUNDARIES OF THE STUDY AREA.**

17 The study area referred to in section 2 shall be com-
18 prised of the counties of Beaufort, Bertie, Camden, Cho-
19 wan, Currituck, Dare, Gates, Halifax, Hertford, Hyde,
20 Martin, Northampton, Pasquotank, Perquimans, Tyrrell,
21 and Washington, North Carolina.

22 **SEC. 4. REPORT.**

23 Not later than 3 fiscal years after the date on which
24 funds are first made available for this Act, the Secretary
25 of the Interior shall submit to the Committee on Resources

1 of the House of Representatives and the Committee on
2 Energy and Natural Resources of the Senate a report on
3 the findings, conclusions, and recommendations of the
4 study.
