A BILL

To designate a Forest Service trail at Waldo Lake in the Willamette National Forest in the State of Oregon as a national recreation trail in honor of Jim Weaver, a former Member of the House of Representatives.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION OF NATIONAL RECREATIONAL**
2 **TRAIL, WILLAMETTE NATIONAL FOREST, OR-**
3 **EGON, IN HONOR OF JIM WEAVER, A FORMER**
4 **MEMBER OF THE HOUSE OF REPRESENTA-**
5 **TIVES.**

6 (a) *DESIGNATION.*—*Forest Service trail number 3590*
7 *in the Willamette National Forest in Lane County, Oregon,*
8 *which is a 19.6 mile trail that begins and ends at North*
9 *Waldo Campground and circumnavigates Waldo Lake, is*
10 *hereby designated as a national recreation trail under sec-*
11 *tion 4 of the National Trails System Act (16 U.S.C. 1243)*
12 *and shall be known as the “Jim Weaver Loop Trail”.*

13 (b) *INTERPRETIVE SIGN.*—*Using funds available for*
14 *the Forest Service, the Secretary of Agriculture shall pre-*
15 *pare, install, and maintain an appropriate sign at the*
16 *trailhead of the Jim Weaver Loop Trail to indicate the*
17 *name of the trail and to provide information regarding the*
18 *life and career of Congressman Jim Weaver.*
