Mr. ROGERS of Michigan introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To improve traffic safety by discouraging the use of traffic signal preemption transmitters.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Safe Intersections Act
5 of 2005”.

6 **SEC. 2. SAFE INTERSECTIONS.**

7 (a) IN GENERAL.—Chapter 2 of title 18, United
8 States Code, is amended by adding at the end the fol-
9 lowing:

1 **“§ 39. Traffic signal preemption transmitters**

2 “(a) OFFENSES.—

3 “(1) SALE.—A person who knowingly sells a
4 traffic signal preemption transmitter in or affecting
5 interstate or foreign commerce to a person who is
6 not acting on behalf of a public agency or private
7 corporation authorized by law to provide fire protec-
8 tion, law enforcement, emergency medical services,
9 transit services, maintenance, or other services for a
10 Federal, State, or local government entity, shall,
11 notwithstanding section 3571(b) of title 18, United
12 States Code, be fined not more than \$10,000, im-
13 prisoned not more than 1 year, or both.

14 “(2) USE.—A person who makes unauthorized
15 use of a traffic signal preemption transmitter in or
16 affecting interstate or foreign commerce shall be
17 fined not more than \$10,000, imprisoned not more
18 than 6 months, or both.

19 “(b) DEFINITIONS.—In this section, the following
20 definitions apply:

21 “(1) TRAFFIC SIGNAL PREEMPTION TRANS-
22 MITTER.—The term ‘traffic signal preemption trans-
23 mitter’ means any mechanism that can change or
24 alter a traffic signal’s phase time or sequence.

25 “(2) UNAUTHORIZED USE.—The term ‘unau-
26 thorized use’ means use of a traffic signal preemp-

1 tion transmitter by a person who is not acting on be-
2 half of a public agency or private corporation au-
3 thorized by law to provide fire protection, law en-
4 forcement, emergency medical services, transit serv-
5 ices, maintenance, or other services for a Federal,
6 State, or local government entity. The term ‘unau-
7 thorized use’ does not apply to use of a traffic signal
8 preemption transmitter for classroom or instruc-
9 tional purposes.”.

10 (b) CHAPTER ANALYSIS.—The chapter analysis for
11 chapter 2 of title 18, United States Code, is amended by
12 adding at the end the following:

“39. Traffic signal preemption transmitters.”.
