Miss MCMORRIS introduced the following bill; which was referred to the Committee on Resources

A BILL

To require the conveyance of a small parcel of Federal land in the Colville National Forest, Washington, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ferry County Hospital
5 Accessibility Act”.

6 **SEC. 2. LAND CONVEYANCE, COLVILLE NATIONAL FOREST,**
7 **WASHINGTON.**

8 (a) CONVEYANCE REQUIRED.—The Secretary of Ag-
9 riculture shall convey, by quit claim deed and without con-
10 sideration, to the Ferry County Public Hospital District

1 No. 1 (in this section referred to as the “recipient”) all
2 right, title, and interest of the United States in and to
3 a parcel of land in the Colville National Forest consisting
4 of approximately 3.274 acres, as depicted on the map enti-
5 tled “Colville Land Conveyance” and dated July 25, 2004,
6 and more particularly described as a portion of Parcel A,
7 Lot 19 of section 6 of township 36 north, range 33 east,
8 Willamette meridian, delineated on Record of Survey, re-
9 corded June 1, 2004, in Book 4 of Surveys, Pages 173
10 and 174, Auditors File No. 259175, Ferry County, Wash-
11 ington.

12 (b) MAP AND LEGAL DESCRIPTION.—In the event of
13 any discrepancy between the map referred to in subsection
14 (a) and the legal description of the land to be conveyed
15 under such subsection, the map shall prevail unless the
16 Secretary determines otherwise. The Secretary may cor-
17 rect any minor errors in the map, the legal description,
18 or encumbrances on the land. The map shall be on file
19 and available for inspection in the Office of the Chief of
20 the Forest Service and the Office of the Supervisor of
21 Colville National Forest.

22 (c) REVOCATION OF LAND WITHDRAWALS.—Any
23 public order withdrawing any portion of the land to be
24 conveyed under subsection (a) from appropriation or dis-

1 posal under the public land laws is revoked to the extent
2 necessary to permit the conveyance of the land.

3 (d) WITHDRAWAL OF FEDERAL LAND.—Subject to
4 valid existing rights, the land to be conveyed under sub-
5 section (a) is withdrawn from all forms of location, entry,
6 and patent under the public land laws, including the min-
7 ing and mineral leasing laws and the Geothermal System
8 Act of 1970 (30 U.S.C. 1001 et seq.) until the date on
9 which the conveyance is completed.

10 (e) COSTS OF IMPLEMENTING THE CONVEYANCE.—
11 The administrative costs of implementing the conveyance
12 of Federal land shall be paid by the recipient.

13 (f) BOUNDARY ADJUSTMENT.—The Secretary shall
14 adjust the boundaries of Colville National Forest to reflect
15 the land conveyance carried out under this section.

16 (g) ADDITIONAL TERMS AND CONDITIONS.—The
17 Secretary may require such additional terms and condi-
18 tions in connection with the conveyance under this section
19 as the Secretary considers appropriate to protect the inter-
20 ests of the United States.
