## A BILL

To amend the Truth in Regulating Act to make permanent  
the pilot project for the report on rules.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1   **SECTION 1. AMENDMENT OF TRUTH IN REGULATING ACT**  
2                   **TO MAKE PERMANENT PILOT PROJECT FOR**  
3                   **REPORT ON RULES.**

4       (a) PURPOSE.—The purpose of this section is to  
5   make permanent the authority to request the performance  
6   of regulatory analysis to enhance Congressional responsi-  
7   bility for regulatory decisions developed under the laws en-  
8   acted by Congress.

9       (b) AMENDMENT.—The Truth in Regulating Act of  
10 2000 (Public Law 106-312, 5 U.S.C. 801 note) is amend-  
11 ed—

12               (1) in the heading for section 4, by striking  
13       **“PILOT PROJECT FOR”**;

14               (2) by striking section 5 and redesignating sec-  
15   tion 6 as section 5; and

16               (3) in section 5 (as redesignated by paragraph  
17   (2))—

18               (A) in the heading, by striking **“AND DU-**  
19       **RATION OF PILOT PROJECT”**;

20               (B) in subsection (a), by striking **“(a) EF-**  
21       **EFFECTIVE DATE.”**; and

22               (C) by striking subsections (b) and (c).

1 **SECTION 1. AMENDMENT TO TRUTH IN REGULATING ACT**2 **TO AUTHORIZE ADDITIONAL 3-YEAR PERIOD**3 **FOR PILOT PROJECT.**4 (a) **ADDITIONAL 3-YEAR PERIOD FOR PILOT**5 *PROJECT.—Section 6(b) of the Truth in Regulating Act of*6 *2000 (Public Law 106-312; 5 U.S.C. 801 note) is amend-*7 *ed—*8 (1) *by striking “The pilot project under this Act”*9 *and inserting the following:*10 “(1) **INITIAL 3 YEARS.—The pilot project under**  
11 *this Act”; and*12 (2) *by inserting at the end the following:*13 “(2) **ADDITIONAL 3 YEARS.—The pilot project**  
14 *under this Act shall continue for an additional period*  
15 *of 3 years, beginning October 1, 2006, and ending*  
16 *September 30, 2009, if in each fiscal year a specific*  
17 *annual appropriation not less than \$5,000,000 shall*  
18 *have been made for the pilot project.”.*19 (b) *AUTHORIZATION.—Section 5 of such Act is amend-*  
20 *ed by inserting before the period at the end of the text the*  
21 *following: “, and \$5,000,000 for each of fiscal years 2007,*  
22 *2008, and 2009”.*23 (c) *TECHNICAL AMENDMENT.—Section 6(c) of such Act*  
24 *is amended by inserting after “3-year period” the following:*  
25 *“under subsection (b)(1)”.*

Amend the title so as to read: “A bill to amend the Truth in Regulating Act to authorize an additional period of 3 years for the pilot project for the report on rules.”.
