## A BILL

To amend the Farm Security and Rural Investment Act of 2002 to extend contracts for national dairy market loss payments through fiscal year 2007, to increase the payment quantity authorized under such contracts, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. NATIONAL DAIRY MARKET LOSS PAYMENTS.**

2 (a) PROGRAM EXTENSION AND CHANGES.—Section  
3 1502 of the Farm Security and Rural Investment Act of  
4 2002 (7 U.S.C. 7982) is amended—

5 (1) in subsection (c)(2)(A), by striking  
6 “\$16.94” and inserting “\$17.10”;

7 (2) in subsection (d)(2)—

8 (A) by striking “2,400,000” and inserting  
9 “4,800,000”; and

10 (B) by striking the second sentence; and

11 (3) in subsections (f) and (g)(1), by striking  
12 “2005” both places it appears and inserting “2007”.

13 (b) PERIOD OF EFFECTIVENESS.—Notwithstanding  
14 section 257 of the Balanced Budget and Emergency Def-  
15 cit Control Act of 1985 (2 U.S.C. 907)—

16 (1) the amendments made by paragraphs (1)  
17 and (2) of subsection (a) shall be effective only dur-  
18 ing the period beginning October 1, 2005, and end-  
19 ing September 30, 2007; and

20 (2) the amendments made by paragraph (3) of  
21 such subsection shall be effective only during the pe-  
22 riod beginning on the first day of the first month be-  
23 ginning after the date of enactment of this Act and  
24 ending September 30, 2007.
