## A BILL

To amend the Farm Security and Rural Investment Act of 2002 to reform funding for the Seniors Farmers' Market Nutrition Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SENIORS FARMERS' MARKET NUTRITION PRO-**  
4 **GRAM.**

5 (a) FUNDING.—Subsection (a) of section 4402 of the  
6 Farm Security and Rural Investment Act of 2002 (7

1 U.S.C. 3007; Public Law 107–171; 116 Stat. 334) is  
2 amended to read as follows:

3 “(a) ESTABLISHMENT.—The Secretary of Agri-  
4 culture shall use funds available to the Commodity Credit  
5 Corporation to carry out and expand a seniors farmers’  
6 market nutrition program in the following amounts:

7 “(1) For fiscal year 2005, not less than  
8 \$25,000,000.

9 “(2) For fiscal year 2006, not less than  
10 \$50,000,000.

11 “(3) For fiscal year 2007, not less than  
12 \$75,000,000.”.

13 (b) PURPOSES.—Subsection (b)(1) of such section is  
14 amended—

15 (1) by striking “unprepared” and inserting  
16 “minimally processed”; and

17 (2) by striking “and herbs” and inserting  
18 “herbs, and other locally produced farm products as  
19 the Secretary considers appropriate”.

20 (c) ADMINISTRATIVE COSTS; UNEXPENDED  
21 FUNDS.—Such section is further amended by adding at  
22 the end the following new subsections:

23 “(d) ADMINISTRATIVE COSTS.—Not more than 10  
24 percent of the funds made available for a fiscal year under

1 subsection (a) may be used to pay administrative costs in-  
2 curred in carrying out this section.

3 “(e) UNEXPENDED FUNDS.—To the extent the funds  
4 made available under subsection (a) for a fiscal year are  
5 not expended in that fiscal year, the Secretary shall use  
6 such funds in a subsequent fiscal year for the same pur-  
7 pose.”.
