Ms. KILPATRICK of Michigan (for herself, Mr. COOPER, Mr. WAMP, Ms. BORDALLO, Mr. McDERMOTT, Mr. PAYNE, Mr. CONYERS, Mr. LEWIS of Georgia, Mr. OWENS, Mrs. JONES of Ohio, Ms. JACKSON-LEE of Texas, Mr. RUSH, Mr. RANGEL, Ms. NORTON, Mr. MEEHAN, Mr. JEFFERSON, Mrs. MALONEY, and Mr. GORDON) introduced the following bill; which was referred to the Committee on Financial Services

A BILL

To posthumously award a congressional gold medal to Wilma G. Rudolph.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress finds that—

5 (1) Wilma G. Rudolph of Clarksville, Ten-
6 nessee, the 20th of 22 children, overcame a series of
7 childhood diseases, including scarlet fever, double
8 pneumonia, and polio, to become an athletic pioneer
9 and champion in the State of Tennessee, the United

1 States, and the world, first as an outstanding bas-
2 ketball player and track athlete in Tennessee, then
3 as a 3-time gold medal winner in the 1960 Olympics
4 in Rome, and finally as a pioneer for racial equality,
5 goodwill, and justice;

6 (2) Wilma G. Rudolph's winning of 3 gold med-
7 als in the 1960 Olympics served as an inspiration to
8 athletes of all sports, all races, and both genders;

9 (3) Wilma G. Rudolph's ability to inspire en-
10 dured after her performance in the 1960 Olympics,
11 as demonstrated by—

12 (A) her receipt in 1987 of the National
13 Collegiate Athletic Association's Silver Anniver-
14 sary Award, the first time a woman ever re-
15 ceived the award;

16 (B) her receipt of the 1989 Jackie Robin-
17 son Image Award of the National Association
18 for the Advancement of Colored People
19 (NAACP);

20 (C) her induction into the National Track
21 and Field Hall of Fame in 1974;

22 (D) her receipt of the 1985 Humanitarian
23 of the Year Award of the Special Olympics; and

1 (E) her receipt in 1993 of the National
2 Sports Award, the only time a woman has re-
3 ceived the award;

4 (4) Wilma G. Rudolph, a graduate of Tennessee
5 State University, a successful businessperson, a
6 mother, an athlete, a coach, and a teacher, who
7 passed away on November 12, 1994, will forever re-
8 main an inspiration to all able-bodied and physically-
9 challenged individuals in overcoming odds;

10 (5) Wilma G. Rudolph blazed a trail that
11 helped all people understand the contributions of
12 women to the world of athletics;

13 (6) the legacy of Wilma C. Rudolph continues
14 to serve as a particular inspiration to women; and

15 (7) Wilma G Rudolph's life truly embodied the
16 American values of hard work, determination, and
17 love of humanity.

18 **SEC. 2. CONGRESSIONAL GOLD MEDAL.**

19 (a) PRESENTATION AUTHORIZED.—The Speaker of
20 the House of Representatives and the President Pro Tem-
21 pore of the Senate shall make appropriate arrangements
22 for the presentation, on behalf of the Congress, of a gold
23 medal of appropriate design, honoring Wilma G. Rudolph
24 (posthumously) in recognition of her outstanding and en-

1 during contributions to humanity and to women's ath-
2 letics, in the United States and the world.

3 (b) DESIGN AND STRIKING.—For the purpose of the
4 award referred to in subsection (a), the Secretary of the
5 Treasury (in this Act referred to as the “Secretary”) shall
6 strike a gold medal with suitable emblems, devices, and
7 inscriptions, to be determined by the Secretary.

8 **SEC. 3. DUPLICATE MEDALS.**

9 The Secretary may strike and sell duplicates in
10 bronze of the gold medal struck pursuant to section 2
11 under such regulations as the Secretary may prescribe,
12 and at a price sufficient to cover the costs thereof, includ-
13 ing labor, materials, dies, use of machinery, overhead ex-
14 penses, and the cost of the gold medal.

15 **SEC. 4. STATUS AS NATIONAL MEDALS.**

16 The medals struck pursuant to this Act are national
17 medals for purposes of chapter 51 of title 31, United
18 States Code.

19 **SEC. 5. FUNDING.**

20 (a) AUTHORITY TO USE FUND AMOUNTS.—There is
21 authorized to be charged against the United States Mint
22 Public Enterprise Fund an amount not to exceed \$30,000
23 to pay for the cost of the medals authorized by this Act.

24 (b) PROCEEDS OF SALE.—Amounts received from the
25 sale of duplicate bronze medals under section 3 shall be

- 1 deposited in the United States Mint Public Enterprise
- 2 Fund.
