## A BILL

To provide for the conveyance of certain real property by the Administrator of General Services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. DEFINITION.
- 4 In this Act, the term "Pavilion Annex" means the
- 5 building (and immediate surroundings, including any land

- 1 unoccupied as of the date of enactment of this Act) in
- 2 Washington, District of Columbia, that is—
- 3 (1) known as the "Pavilion Annex";
- 4 (2) adjacent to the Old Post Office Building;
- 5 (3) located on Pennsylvania Avenue, N.W., to
- 6 the east of 11th Street, N.W.; and
- 7 (4) located on land bounded on three sides by
- 8 the Internal Revenue Service buildings.

## 9 SEC. 2. CONVEYANCE OF LAND.

- 10 (a) Conveyance Required.—The Administrator of
- 11 General Services shall convey, without consideration, to a
- 12 nonprofit, nonpartisan educational institution incor-
- 13 porated in the District of Columbia in 1996 for the pur-
- 14 pose of establishing a women's history museum, all right,
- 15 title, and interest of the United States in and to a parcel
- 16 of Federal real property, including improvements thereon,
- 17 known as the "Pavilion Annex". After such conveyance,
- 18 the property may be used and occupied only by the mu-
- 19 seum.
- 20 (b) Description of Property.—The exact acreage
- 21 and legal description of the real property to be conveyed
- 22 under subsection (a) shall be determined by a survey satis-
- 23 factory to the Administrator. The cost of the survey shall
- 24 be borne by the museum.

- 1 (c) REVERSIONARY INTEREST.—During the 20-year
- 2 period beginning on the date the Administrator makes the
- 3 conveyance under subsection (a), if the Administrator de-
- 4 termines that the conveyed property is not being used and
- 5 occupied in accordance with such subsection, all right,
- 6 title, and interest in and to the property, including any
- 7 improvements thereon, shall revert to the United States.
- 8 Upon reversion, the United States shall immediately pro-
- 9 ceed to a public sale of the property.
- 10 (d) Additional Terms and Conditions.—(1) The
- 11 property shall not be used for commercial purposes.
- 12 (2) The Administrator may require such additional
- 13 terms and conditions in connection with the conveyance
- 14 under subsection (a) as the Administrator considers ap-
- 15 propriate to protect the interests of the United States.
