## A BILL

To rename the Snake River Birds of Prey National Conservation Area in the State of Idaho as the Morley Nelson Snake River Birds of Prey National Conservation Area in honor of the late Morley Nelson, an international authority on birds of prey, who was instrumental in the establishment of this National Conservation Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Morley Nelson Snake  
5 River Birds of Prey National Conservation Area Act”.

1 **SEC. 2. RENAMING OF SNAKE RIVER BIRDS OF PREY NA-**  
2 **TIONAL CONSERVATION AREA.**

3 (a) RENAMING.—Public Law 103–64 is amended—

4 (1) in section 2(2) (16 U.S.C. 460iii–1(2)), by  
5 inserting “Morley Nelson” before “Snake River  
6 Birds of Prey National Conservation Area”; and

7 (2) in section 3(a)(1) (16 U.S.C. 460iii–  
8 2(a)(1)), by inserting “Morley Nelson” before  
9 “Snake River Birds of Prey National Conservation  
10 Area”.

11 (b) REFERENCES.—Any reference in a law, map, reg-  
12 ulation, document, paper, or other record of the United  
13 States to the Snake River Birds of Prey National Con-  
14 servation Area shall be deemed to be a reference to the  
15 Morley Nelson Snake River Birds of Prey National Con-  
16 servation Area.

17 (c) TECHNICAL CORRECTIONS.—Public Law 103–64  
18 is further amended—

19 (1) in section 3(a)(1) (16 U.S.C. 460iii–  
20 2(a)(1)), by striking “(hereafter referred to as the  
21 ‘conservation area’)”; and

22 (2) in section 4 (16 U.S.C. 460iii–3)—

23 (A) in subsection (a)(2), by striking “Con-  
24 servation Area” and inserting “conservation  
25 area”; and

- 1 (B) in subsection (d), by striking “Visitors
- 2 Center” and inserting “visitors center”.
