## A BILL

To direct the Secretary of Veterans Affairs to conduct a pilot program to improve access to health care for rural veterans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Rural Veterans Access
- 5 to Care Act of 2005".

### 1 SEC. 2. PILOT PROGRAM FOR IMPROVED ACCESS TO

- 2 HEALTH CARE FOR RURAL VETERANS.
- 3 (a) PILOT PROGRAM.—The Secretary of Veterans Af-
- 4 fairs shall conduct a pilot program for a means to improve
- 5 access to medical services for highly rural or geographi-
- 6 cally remote veterans through expanded use of the Sec-
- 7 retary's contract authority under section 1703 of title 38,
- 8 United States Code, and other authorities available to the
- 9 Secretary to improve such access.
- 10 (b) Areas for Conduct of Pilot Program.—The
- 11 pilot program shall be conducted in three geographic serv-
- 12 ice regions, referred to as Veterans Integrated Service
- 13 Networks, of the Veterans Health Administration. The
- 14 Secretary shall select the Veterans Integrated Service Net-
- 15 work designated as Number 23 as one of the regions for
- 16 the conduct of the pilot program and shall select the other
- 17 two from those Veterans Integrated Service Networks that
- 18 have a substantial population of highly rural or geographi-
- 19 cally remote veterans (as determined under subsection
- 20 (f)).
- 21 (c) Medical Services Under Pilot Program.—
- 22 Under the pilot program, the Secretary shall provide,
- 23 through the use of the Secretary's contract authority
- 24 under section 1703 of title 38, United States Code, and
- 25 other authorities available to the Secretary, for the treat-

- ment of covered veterans by health-care providers outside 2 the Department of Veterans Affairs for the following: 3 (1) Acute or chronic symptom management. (2) Nontherapeutic medical services. (3) Other medical services as determined appro-6 priate in the case of any veteran by the director of 7 the appropriate geographic service region of the De-8 partment, after consultation with the Department 9 physician responsible for primary care of the vet-10 eran. 11 (d) Funds for Pilot Program.—For any fiscal year during which the pilot program is conducted, the Secretary shall allocate for the pilot program 0.9 percent of the total amount appropriated for that fiscal year for Med-14 ical Services. Such allocation shall be made before any other allocation of such funds is made, and any remaining 16 allocation of such funds for any such fiscal year shall be made without regard to the allocation under the preceding 18 19 sentence. 20 (e) Covered Veterans.—For the purposes of this
- 20 (e) COVERED VETERANS.—For the purposes of this 21 section, covered veterans are veterans—
- 22 (1) who are enrolled in the veterans health care 23 system under section 1705 of this title or have a 24 service-connected disability; and

- 1 (2) who, pursuant to subsection (f), are consid-
- 2 ered to be highly rural or geographically remote vet-
- 3 erans.
- 4 (f) Highly Rural or Geographically Remote
- 5 Veterans.—The Secretary shall prescribe by regulation
- 6 standards for determination of which veterans are consid-
- 7 ered to be highly rural or geographically remote veterans
- 8 for the purposes of this section. The Secretary shall in-
- 9 clude as such a veteran any veteran for whom the driving
- 10 distance to reach a Department health-care facility is 60
- 11 miles or greater. The Secretary may provide for a lesser
- 12 driving distance in the case of any veteran if the Secretary
- 13 determines that driving 60 miles or more imposes a hard-
- 14 ship on such veteran or otherwise is not in the best inter-
- 15 est of the veteran.
- 16 (g) Period of Pilot Program.—The pilot program
- 17 shall be conducted during fiscal years 2006, 2007, and
- 18 2008.
- 19 (h) REPORT TO CONGRESS.—Not later than Feb-
- 20 ruary 1, 2009, the Secretary shall submit to Congress a
- 21 report on the operation of the pilot program. The Sec-
- 22 retary shall include in the report such recommendations
- 23 as the Secretary considers appropriate concerning exten-
- 24 sion of the pilot program or other means to improve access

- 1 to medical services for highly rural or geographically re-
- 2 mote veterans.
