A BILL

To direct the Secretary of the Interior to extend certain water contracts in Idaho, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. IDAHO WATER CONTRACTS EXTENSION.**

4 (a) **AUTHORITY TO EXTEND WATER CONTRACTS.—**

5 Unless a non-Federal party to the contract objects, the
6 Secretary of the Interior shall extend each of the water
7 contracts listed in subsection (b) without altering any
8 other terms of such contracts until the earlier of—

1 (1) the expiration of the 2-year period begin-
2 ning on the date on which the contract would expire
3 but for this section; or

4 (2) the date on which a new water contract is
5 executed by the parties to the contract.

6 (b) EXTENDED CONTRACTS.—The water contracts
7 referred to in subsection (a) are the following:
