1 **SECTION 1. PROCEDURES FOR CONSIDERING AMEND-**
2 **MENTS AND RESOLUTIONS UNDER THE ALAS-**
3 **KA NATIVE CLAIMS SETTLEMENT ACT.**

4 Section 36(d)(3) of the Alaska Native Claims Settle-
5 ment Act (43 U.S.C. 1629b(d)(3)) is amended by insert-
6 ing after “of this section” the following: “or an amend-
7 ment to the articles of incorporation described in section
8 7(g)(1)(B)”.

9 **SEC. 2. TECHNICAL CORRECTIONS.**

10 (a)(1) Section 337(a) of the Department of the Inte-
11 rior and Related Agencies Appropriations Act, 2003 (Divi-

14 (A) in the matter preceding paragraph (1), by
15 striking “Section 1629b of title 43, United States
16 Code,” and inserting “Section 36 of the Alaska Na-
17 tive Claims Settlement Act (43 U.S.C. 1629b)”;

18 (B) in paragraph (2), by striking “by creating
19 the following new subsection:” and inserting “in sub-
20 section (d), by adding at the end the following:”.

21 (2) Section 36 of the Alaska Native Claims Settle-
22 ment Act (43 U.S.C. 1629b) is amended—

23 (A) in subsection (d)(3), by striking “(d)”;

24 (B) in subsection (f), by striking “section
25 1629e of this title” and inserting “section 39”.

1 (b)(1) Section 337(b) of the Department of the Inte-
2 rior and Related Agencies Appropriations Act, 2003 (Divi-
3 sion F of Public Law 108–7; 117 Stat. 278; February 20,
4 2003) is amended by striking “Section 1629e(a)(3) of title
5 43, United States Code,” and inserting “Section 39(a)(3)
6 of the Alaska Native Claims Settlement Act (43 U.S.C.
7 1629e(a)(3))”.

8 (2) Section 39(a)(3)(B)(ii) of the Alaska Native
9 Claims Settlement Act (43 U.S.C. 1629e(a)(3)(B)(ii)) is
10 amended by striking “(a)(4) of section 1629b of this title”
11 and inserting “section 36(a)(4)”.

12 (c) The amendments made by this section take effect
13 on February 20, 2003.
