## A BILL

To amend title 38, United States Code, to provide for the payment of a monthly stipend to the surviving parents (known as "Gold Star parents") of members of the Armed Forces who die during a period of war.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Gold Star Parents An-
- 5 nuity Act".

### 1 SEC. 2. SPECIAL PENSION FOR GOLD STAR PARENTS.

- 2 (a) IN GENERAL.—(1) Chapter 15 of title 38, United
- 3 States Code, is amended by adding at the end the fol-
- 4 lowing new subchapter:
- 5 "SUBCHAPTER V—SPECIAL PENSION FOR GOLD
- 6 STAR PARENTS

### 7 "§ 1571. Gold Star parents

- 8 "(a) The Secretary shall pay monthly to each person
- 9 who has received a Gold Star lapel pin under section 1126
- 10 of title 10 as a parent of a person who died in a manner
- 11 described in subsection (a) of that section a special pen-
- 12 sion in an amount determined under subsection (b).
- 13 "(b) The amount of special pension payable under
- 14 this section with respect to the death of any person shall
- 15 be \$125 per month. In any case in which there is more
- 16 than one parent eligible for special pension under this sec-
- 17 tion with respect to the death of a person, the Secretary
- 18 shall divide the payment equally among those eligible par-
- 19 ents.
- 20 "(c) The receipt of special pension shall not deprive
- 21 any person of any other pension or other benefit, right,
- 22 or privilege to which such person is or may hereafter be
- 23 entitled under any existing or subsequent law. Special pen-
- 24 sion shall be paid in addition to all other payments under
- 25 laws of the United States.

- 1 "(d) Special pension shall not be subject to any at-
- 2 tachment, execution, levy, tax lien, or detention under any
- 3 process whatever.
- 4 "(e) For purposes of this section, the term 'parent'
- 5 has the meaning provided in section 1126(d)(2) of title
- 6 10.".
- 7 (2) The table of sections at the beginning of such
- 8 chapter is amended by adding at the end the following:
  "SUBCHAPTER V—SPECIAL PENSION FOR GOLD STAR PARENTS
  "1571. Gold Star parents.".
- 9 (b) Effective Date.—Section 1571 of title 38,
- 10 United States Code, as added by subsection (a), shall take
- 11 effect on the first day of the first fiscal year beginning
- 12 after the date of the enactment of this Act.
