A BILL

To amend the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005 to exempt from the means test in bankruptcy cases, for a limited period, qualifying reserve-component members who, after September 11, 2001, are called to active duty or to perform a homeland defense activity for not less than 60 days.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AMENDMENT.**

4 Section 101(a)(2)(C) of the Bankruptcy Abuse Pre-
5 vention and Consumer Protection Act of 2005 (Public

1 Law 109–8) is amended by adding at the end of para-
2 graph (2) of section 707(b) of title 11 of the United States
3 Code, as added by such Act, the following:

4 “(E) Subparagraphs (A) through (C) shall not apply,
5 and the court may not dismiss or convert a case filed
6 under this chapter based on any form of means testing—

7 “(i)(I) while the debtor is on, and during the
8 180-day period beginning immediately after the
9 debtor is released from, a period of active duty (as
10 defined in section 101(d)(1) of title 10) of not less
11 than 60 days; or

12 “(II) while the debtor is performing, and during
13 the 180-day period beginning immediately after the
14 debtor is no longer performing, a homeland defense
15 activity (as defined in section 901(1) of title 32) per-
16 formed for a period of not less than 60 days; and

17 “(ii) if after September 11, 2001, the debtor
18 while a member of a reserve component of the
19 Armed Forces or a member of the National Guard,
20 was called to such active duty or performed such
21 homeland defense activity.”.

22 **SEC. 2. EFFECTIVE DATE; APPLICATION OF AMENDMENT.**

23 (a) **EFFECTIVE DATE.**—Except as provided in sub-
24 section (b), this Act and the amendment made by this Act
25 shall take effect on April 20, 2005.

1 (b) APPLICATION OF AMENDMENTS.—The amend-
2 ment made by this Act shall apply only with respect to
3 cases commenced under title 11 of the United States Code
4 after April 20, 2005.
