## A BILL

To extend the existence of the Parole Commission, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “United States Parole  
5 Commission Extension and Sentencing Commission Au-  
6 thority Act of 2005”.

1 **SEC. 2. EXTENSION OF EXISTENCE OF THE PAROLE COM-**  
2 **MISSION.**

3 For purposes of section 235(b) of the Sentencing Re-  
4 form Act of 1984 (98 Stat. 2032) as such section relates  
5 to chapter 311 of title 18, United States Code, and the  
6 United States Parole Commission, each reference in such  
7 section to “eighteen years” or “eighteen-year period” shall  
8 be deemed a reference to “21 years” or “21-year period”,  
9 respectively.

10 **SEC. 3. PROVISION OF EMERGENCY AMENDMENT AUTHOR-**  
11 **ITY FOR SENTENCING COMMISSION.**

12 In accordance with the procedure set forth in section  
13 21(a) of the Sentencing Act of 1987 (Public Law 100–  
14 182), as though the authority under that Act had not ex-  
15 pired, the United States Sentencing Commission shall—

16 (1) not later than 60 days after the date of the  
17 enactment of this Act, amend the Federal sentencing  
18 guidelines, commentary, and policy statements to  
19 implement section 6703 of the Intelligence Reform  
20 and Terrorism Prevention Act of 2004 (Public Law  
21 108–458); and

22 (2) not later than 180 days after the date of  
23 the enactment of this Act, amend the Federal sen-  
24 tencing guidelines, commentary, and policy state-  
25 ments to implement section 3 of the Anabolic Ster-  
26 oid Control Act of 2004 (Public Law 108–358).
